

## Sharon Center School Board of Education

The Regular Meeting of the Sharon Board of Education was held on Monday, March 8, 2021 as a virtual meeting.

The meeting was called to order at 6:02 p.m. by Chair Doug Cahill.

Chair Doug Cahill requested an amendment to the agenda, suggesting that item #9 be an open discussion regarding the extension of the appointment of Jill Pace to serve as Co-Assistant Superintendent for the 2021-2022 school year. The Board could then move into Executive Session for further discussion if they felt it necessary to do so.

*Motion by Anne Vance/2<sup>nd</sup> by Monica Connor to approve the agenda as amended. Motion carried by unanimous vote.*

Spotlight on Student Learning focused on School Counselor, Liz Foster. Mrs. Foster shared the Community Resources with whom she collaborates in her work with students and families.

*Motion by Anne Vance/2<sup>nd</sup> by Amanda Thompson to accept the Consent Agenda. Motion carried by unanimous vote.*

No Public Comment was heard.

Janet Carlson of the One Eleven (111) group reviewed the work they have completed to date, and shared with the Board their goals for next year.

*Motion by Deborah Rathbun/2<sup>nd</sup> by Anne Vance to accept the One Eleven Group's proposal for 2021-2022. Motion carried by unanimous vote.*

The Assistant Superintendents reviewed their March reports to the Board.

Principal Manning reported that the Virtual Read-Aloud was very successful, with some of the readers commenting that they would like to do it again.

Congratulations go to 8<sup>th</sup> grade students Keiana Wallace and Charlotte Smith, winners of the CAS Elementary Art Award. They will be honored on March 30<sup>th</sup>.

Superintendent Lisa Carter reviewed her March report. March is Board Appreciation Month, so she thanked the Board members for their dedication and support and for all they do for the school and Region 1.

ABC Committee Update: A 2 ½ year contract with Lisa Carter for the position of Superintendent was approved and signed at the ABC Committee meeting on February 24, 2021.

Update on the Assistant Superintendent search: The Search Committee gave a unanimous vote of approval for continuing the current dual role of Jill Pace and Scott Fellows to share the Assistant Superintendent position for the 2021-2022 school year. Jill would be at a .4 position, with Scott at a .6 position.

Discussion followed regarding approval of extending the appointment of Jill Pace to serve as Co-Assistant Superintendent at a .4 position. Jill spoke in detail about her plans as Media Specialist at Sharon Center School and how this dual role would benefit both Sharon Center School and Region 1.

*Motion by Deborah Rathbun/2<sup>nd</sup> by Monica Connor to support the contract extension for Jill Pace as .4 Co-Assistant Superintendent for the 2021-2022 school year. Motion carried with five yea votes (Doug Cahill, Monica Connor, Deborah Rathbun, Anne Vance, and Kathleen Visconti) and two nay votes (Plamen Petkov and Amanda Thompson).*

*Motion by Anne Vance/2<sup>nd</sup> by Monica Connor to maintain the Tuition Rate for Non-Resident Students for 2021-2022 at the current rate:*

*1<sup>st</sup> child in family \$2,200.00*

*2<sup>nd</sup> child in same family \$2,000.00*

*3<sup>rd</sup> child in same family \$1,800.00*

There was a request from a non-resident family that their daughter be allowed to attend Sharon Center School as a tuition student for grade K for 2021-2022.

*Motion by Monica Connor/2<sup>nd</sup> by Deborah Rathbun to approve this request for a non- resident student to attend Sharon Center School during 2021-2022 school year, as a kindergarten student. Motion carried by unanimous vote.*
