BOOST Funding Agreement

Initial

1. Be a current BOOST member in good standing according to the BOOST policy guide .	
2. BOOST will provide financial support for degree- and credential-related expenses—including tuition, fees, books, exam costs and other expenses—to help participants complete their undergraduate education, teacher preparation program, and transition into credentialed teaching roles.	
3. Each participant may receive up to \$4,500 per academic year. Award amounts will be reassessed annually according to available grant funds. All funding under this program will terminate on June 30, 2028.	
4. Funding will be provided as a living stipend, issued through participants' paycheck or pay warrant as an additional payment. This stipend is considered taxable income. Participants should seek guidance from a qualified tax professional regarding individual tax obligations or tax-related questions.

_____ (D) Comply with the program requirements of the BOOST program established by the District.
