BUDGET IMPACT:

If this resolution is adopted, the Board of Education will reaffirm its commitment to student civil liberties; encourage schools to continue offering courses such as AP US History, AP US Government, and Constitutional Law; encourage schools to promote student participation in civic engagement initiatives; formally request that schools promote and display the LAUSD Student Bill of rights; and call upon all educational institutions to safeguard the civil liberties of their students and to promote the exercise of those liberties (including by choosing not to call police to a peaceful and nonviolent assemblies).

Current program budgets for the Division of Communication, Engagement, and Collaboration, the Division of Instruction, and the Office of the Superintendent will be leveraged to implement this resolution. The proposed resolution will require additional resources to print and distribute the Student Bill of Rights posters to each campus. The estimated cost for two laminated 30" x 40" posters per school is \$61,356.00.

Should there be additional costs to create and distribute additional communications materials or to impact course offerings, this resolution may incur additional costs. However, the exact budget impact cannot be quantified at this time.
