Policy Impact:

This Resolution would support the enactment of SB 1137 (Gonzalez, 2022) which has been suspended since 2023 while opponents pursue a ballot referendum.

In 2022, the Legislature approved, and the Governor signed, SB 1137 (Gonzalez), a measure prohibiting the construction and operation of gas and oil wells within 3,200 feet of a school, and other specified locations. At that time, Los Angeles Unified did not take a position on SB 1137. The challenged law includes:

- Prohibits most new or modified oil and gas wells within 3,200 feet of specified locations, including housing, schools, daycares, parks, healthcare facilities, community resource centers, detention facilities, and businesses open to the public.
- Requires existing wells in these areas meet specified health, safety, and environmental requirements by January 1, 2025.

While the legislative measure became effective on January 1, 2023, it was suspended on February 3, 2023, after opponents (oil and gas companies) collected enough signatures to qualify a referendum for the ballot in order to officially overturn the law

On November 5, 2024, voters will consider the referendum ballot measure. If the measure receives more than 50% of the vote, SB 1137 will become law once again. If it receives less than the 50% threshold, the measure will not go into effect.
