
Governor's 2025-26 State Budget Proposals

February 18, 2025

Overview of Governor's 2025-26 State Budget



- Projected state General Fund of \$228.9 billion
- Prop. 98 guarantee of \$118.9 billion
- Prop. 98 Rainy Day Fund balance of \$1.5 billion
- 2.43% COLA for LCFF and Categorical programs
- \$2.4 billion for full implementation of TK
 - Additional \$1.5 billion to reduce ratio to 10:1
- \$4.4 billion for Expanded Learning Opportunities
 Program (ELO-P)
- \$1.04 billion for Arts and Music Grants (Prop. 28)

Overview of Governor's 2025-26 State Budget



New One-Time Funding Proposals

- \$1.8 billion for Student Support and Discretionary Block Grant
- \$500 million for TK-12 Literacy and Math Coaches
- \$378 million for Learning Recovery Emergency Block Grant
- \$150 million for teacher candidate supports through Teacher Recruitment Incentive Grant
- \$100 million to extend the National Board Certification Incentive Program
- \$150 million to expand Kitchen Infrastructure and Training grants
- \$40 million for literacy screenings to support purchase of materials and training

SSC's Fiscal Report recommends that LEAs only incorporate COLA changes for the Second Interim Financial Report.

Transitional Kindergarten 10:1 Staffing Ratio (Additional Funding)*	\$44M	Ongoing
Student Support and Professional Development Discretionary Block Grant (New)	\$120M	One-time
TK-12 Literacy and Math Coaches (Additional Funding)	\$95M	One-time
Learning Recovery Emergency Block Grant (Additional Funding)	\$34M	One-time

- SSC's Fiscal Report recommends that LEAs only incorporate COLA changes at Second Interim.
- LACOE recommends also including additional TK funding at Second Interim.
- The ELO-P allocation formula may change based on the Governor's Proposal, so the fiscal impact is unknown.
- Assumptions may change at the Governor's May Revision.

State Advocacy Priorities



2025 Budget Priorities

- Maintain or increase the projected cost of living adjustment (COLA) for FY 2025-26
- Protect LCFF and maintain flexibility and local control through avoidance of additional categorical programs
- Amend universal Transitional Kindergarten penalties, and fully fund required TK ratio and class size requirements
- Support investments in school facilities construction, modernization, and greening projects
- Address ADA/funding impacts related to immigration and wildfires
