The Los Angeles Board of Education acting as the Governing Board of the Los Angeles Unified School District met for the Annual meeting on Tuesday, December 10, 2024, at the Administrative Offices, Board Room, 333 South Beaudry Avenue, Los Angeles, California.

Mr. Michael A. McLean, Executive Officer of the Board, called the meeting to order at 10:06 a.m. and commenced the Oath of Office Ceremony.
