Policy Impact

The Biden administration is leading an effort to make the 2030 Census more inclusive and representative of the nation. Specifically, there is a proposal to re-design the race & ethnicity question to more accurately reflect the reality for Latinos and MENA (Middle Eastern or North African) individuals. There will be a new checkbox for "Middle Eastern or North African" as well as a "Hispanic or Latino" box under a re-designed race or ethnicity question.

Currently, the federal government categorizes people of Lebanese, Iranian, Egyptian, and other countries in the MENA region as white, despite that many MENA descendants do not identify as

white themselves. The new proposal will remove the definition of "White" for people from the MENA region.

For Latinos, "Hispanic or Latino" is being reclassified as a standalone <u>racial</u> category, with a list of <u>ethnic</u> subcategorizes to choose from, i.e. Mexican or Mexican American, Puerto Rican, Cuban, etc.

Additional proposals being considered: the removal of "Negro" to describe the "Black" category; the removal of "Far East" to describe the geographic region of origin for people of Asian descent; and the removal of the terms "majority" and "minority."

RECOMMENDATION: Support the proposals currently being considered by the Office of Management and Budget

<u>Next steps</u>: The deadline to submit public comment to the Office of Management and Budget on these proposals is Thursday, April 27, 2023.
