Public comment can be made in-person or by telephone only, and members of the public must sign up online for either method, as described above. Members of the public can only make remote public comment by calling 213-338-8477 and entering the Meeting ID: 832 3386 6360

Each speaker will be allowed a single opportunity to provide comments to the Board, and shall be given three minutes for their remarks. Speakers signed up to speak on an agenda item must constrain their remarks specifically to the item or items on the agenda or may be ruled out of order.
