The Los Angeles Board of Education acting as the Governing Board of the Los Angeles Unified School District met in regular session on Wednesday, January 28, 2026, at the Administrative Offices, Board Room, 333 South Beaudry Avenue, Los Angeles, California.

Mr. McLean announced the following reportable actions resulting from the closed session discussion:

- The Board of Education approved the expulsion of students in case numbers, 27-25/26, 28-25/26, and 30-25/26 with the recommended dispositions. The vote was 7 ayes.
- The Board of Education approved the expulsion of student in case number 29-25/26 with the recommended dispositions. The vote was 6 ayes, 1 no (Mr. Schmerelson).
- The Board of Education approved the conditional enrollment of students in case numbers, 13A-25/26 and 14A-25/26, with the recommended dispositions. The vote was 7 ayes.
- The Board of Education authorized the dismissal of 1 classified employee. The vote was 7 ayes.
- The Board of Education appointed Donald R. Graham, Jr., to the position of Chief of Police with the term beginning on February 11, 2026, and ending on June 30, 2028. Terms and conditions will be available upon the finalization of the agreement. The vote was 5 ayes and 2 noes (Ms. Griego and Dr. Rivas).
- The Board of Education appointed Beiwei Tu to the position of Chief Risk Officer with the term beginning on February 11, 2026, and ending on June 30, 2028. Terms and conditions will be available upon the finalization of the agreement. The vote was 7 ayes.
- The Board of Education appointed Woineshet Gebeyaw to the position of Director of Budget Services & Financial Planning with the term beginning on February 11, 2026, and ending on June 30, 2028. Terms and conditions will be available upon the finalization of the agreement. The vote was 7 ayes.

- The Board of Education appointed Adrian Pacheco to the position of Deputy Director of Facilities Maintenance and Operations with the term beginning on February 11, 2026, and ending on June 30, 2028. Terms and conditions will be available upon the finalization of the agreement. The vote was 7 ayes.
- The Board of Education authorized the settlement in the case of Doe, Jane I, et al. v. Los Angeles Unified School District, et al. (LASC Case No. 22VECV02618). Terms and conditions will be available upon the finalization of the agreement. The vote was 7 ayes.

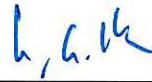
