

### **School Safety**

- Los Angeles Unified is committed to providing every student and all members of our District and school communities with a safe, healthy, welcoming and respectful learning and working environment.
- The District's Every School Safe 2023-2026 Blueprint for Safety is the comprehensive safety plan for all existing and developing systems, programs and resources that reflect this commitment.
- All components are aligned and interconnected to the priorities and strategies reflected in the Los Angeles Unified Strategic Plan.
- The Division of School Operations (DSO) and the Los Angeles School Police Department (LASPD) play a critical role in ensuring Districtwide safety and security and alignment with the Blueprint for Safety.
- As part of that critical work, these departments continually review and refine policies and procedures for campus support.

#### **Positive Behavior** Support

LA Unified's Discipline Foundation Policy (DFP) is based on a nationally-recognized, evidence-based Positive Behavior Intervention and Support framework and Restorative Practices

School-level implementation measured by the Tiered Fidelity Inventory (TFI).



### District Safety Budget, 23-24 School Year

Nearly \$350 million allocated to safety related positions and third-party support services -- this does not account for the millions of dollars being invested in school facilities and technology.

## Los Angeles School Police Department Budget

### 2023-2024 LASPD Budget

- \$44.5 million for Sworn Peace Officer Positions
- Approximately \$592,000 for diversion program's four Pupil Services Counselors
- \$1.56 million for Mental Health Evaluation Team (MHET)
- NEW: ~\$3.7 million from vacant officer positions for CBSP Programs for non-BSAP schools
  - Unspent funds will carryover to 2024-2025 budget for use on the same programs and resources

# School Police On-Campus Deployment

Short-term, on campus deployments of LASPD Officers are authorized in response to:

- Mass School Threats (MST)
- Community Violence impacting campuses
- On campus acts of violence

When deployment occurs, other non-law enforcement resources are also provided, including:

- Appropriate Region Staff
- Mental Health Support
- Community-Based Resources

To date in 2023-24, out of ~780 sites, there have been a total of 41 short-term deployments across 36 campuses

## School Police On-Campus Deployment

School Principals Principals submit a request for support to the Administrator of Operations (AOO). Requests are immediately reviewed by the AOO and forwarded as appropriate. Within 3 days, principals must submit supporting documentation for the request.

Administrator of Operations

If Administrator of Operations supports request, it is sent to the Chief of School Operations (DSO)



If DSO supports, the request is sent to LASPD for final approval and officer deployment



LASPD Officer
Deployment

Deployment lasts for no more than one week with a reassessment at the end of the initial deployment week

Bulletin *Procedures for Requesting Short-Term School Police Support Due to Safety Concerns* formalizes process for greater clarity among practitioners

# Revision to LASPD Policy: Use of Oleoresin Capsicum (OC) Spray

(often referred to as pepper spray)

#### **Current Guidance for LASPD Officers:**

- May be considered for use as self-defense or defending others from imminent threat, or actual use of physical force of violence
- Not used to disperse crowds
- Not to be used on campus involving persons who reasonably appear to be K-12 students or minors

#### **Revised Guidance for LASPD Officers:**

- Not used against persons who reasonably appear to be a juvenile on or off LAUSD campuses
  - \*\*An "exception clause" to this language will be evaluated to address rare circumstances when an officer must defend against an act of physical violence in progress that appears likely to result in serious bodily injury to any person, including officers, or for the preservation of life, and other force options or other intervention alternatives are not objectively reasonable or available at the time.
- LASPD currently evaluating feasibility of OC gel/foam options in place of spray
