

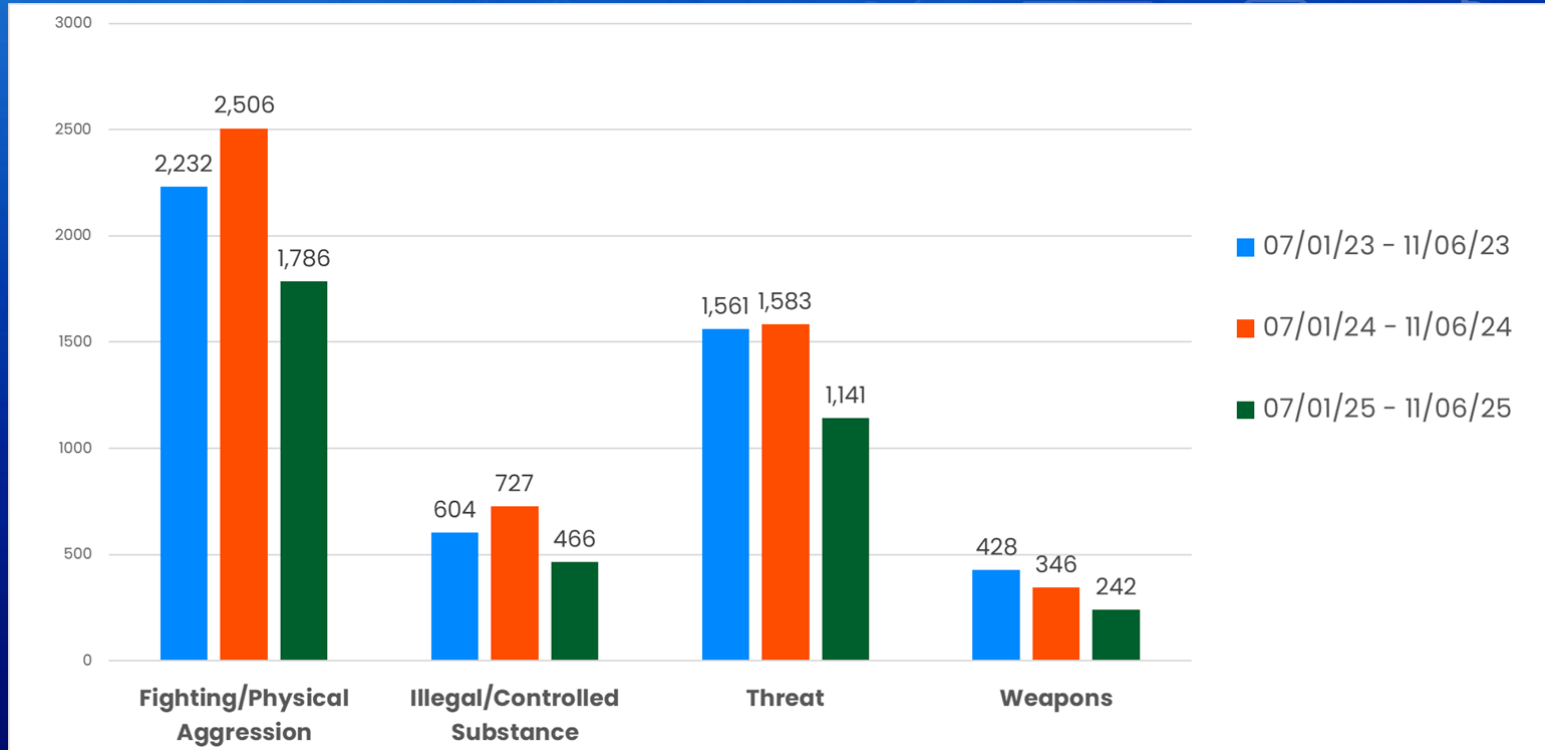

- Ratio of incidents to students based on enrollment has decreased

- YTD 24-25 vs 25-26 changes showed majority decreases across BDs with two areas showing increase (red)

Data Takeaways

Overall Incident Reduction Indicates Positive Impact of Safety Measures

- Year-to-date (YTD) data shows a decrease in major incident categories (fighting, drugs, threats, weapons) compared to the same period last year.
- Fighting/physical aggression dropped by 22.2% per 1,000 students, and illegal substances by 30%, suggesting interventions are working.

Adjusting for Enrollment Confirms Progress

- Despite a decrease in overall student enrollment (from ~437K to ~400K), the incident rate per 1,000 students still declined across all categories.
- This indicates improvements are not just due to fewer students but reflect behavioral and safety gains.
