Any individual wishing to address the Board must register to speak using the Speaker Sign Up website: <https://boardmeeting.lausd.net/speakers>, and indicate whether comments will be provided over the phone or in person. Registration will open 24 hours before the meeting. A maximum of 15 speakers may sign up for general Public Comment. Each speaker will be allowed a single opportunity to provide comments to the Committee.

Speakers who do not register online to provide comments may use the following alternative methods to provide comments to Board Members:

2. Press #, and then # again when prompted for the Participant ID.
3. Remain on hold until it is your turn to speak.
4. Call in from the same phone number entered on the Speaker Sign Up website. If you call in from a private or blocked phone number, we will be unable to identify you.
5. When you receive the signal that your phone has been removed from hold and/or unmuted, please press *6 (Star 6) to be brought into the meeting.

Community School Park Concept



Goal – Increase Public Access to Open Spaces, Parks, and Playgrounds, Particularly for Residents in Low-Income Communities, by Allowing the City to Utilize School Sites

- School Sites Can be Open to the Public During Weekends, School Holidays, and Vacation Periods
- Programmed and Staffed by City of LA Recreation and Parks(RAP) Department for Recreational Activities at no Cost to the Public
- City is responsible for operation, maintenance, security and staffing
- No Cost to LAUSD

Community School Park History



- April 2017 – BOE Authorized Staff to Execute the Community School Parks (CSP) Memorandum of Understanding (MOU) for a One-Year Pilot Program
- November 2017 – Board of Rec and Park Commissioners (City) Approved the MOU
- December 2017 – City and LAUSD Executed the MOU
- January 2018 – RAP Opens 4 CSPs to the Community

Identifying CSP Sites

- RAP Identified Park–Poor Areas and Ranked Them Based on a Set of Criteria Including:
 - Lack of Green Space and Tree Canopy
 - Located in Park Deficient Areas
 - Located in Disadvantaged Communities
 - # of Residents Served Within a ½ Mile (10 Minute Walk)
 - CalEnviroScreen 3.0 – Environmental Justice Tool
- Working With LAUSD Staff, Identified Schools That Align with RAP Priorities

Community School Park Program



- RAP Selected School Sites From Their Priority List:
 - Highest Overall Score (Based on Multiple Factors)
 - Ability to Provide Access to Highest Number of Nearby Residents
- By Early 2018, RAP Had Opened 4 CSP's
 - 75th St. Elementary School
 - Cahuenga Elementary School
 - Harvard Elementary School
 - Leo Politi Elementary School
- Schools Were Open On Saturday and Sunday 10AM–4PM

RAP Lessons Learned – Pilot CSPs



- Lack of Awareness that Schools Were Open for Public Use
- Need to Provide Consistent, Structured Recreational Programs
- Elementary School Play Yards not “Park Like”
 - Lacking Grass Fields, Landscaping, and Recreational Space
- Program Suspended During COVID and Post-COVID RAP Having Difficulty Hiring Staff for the Program

Lessons Learned Shifts RAP Focus

- RAP Focusing on Middle Schools and Sites with More Recreation Space
- Currently Open Saturdays at:
 - Obama Global Prep MS
 - Bethune MS
 - Northridge MS



- Providing Structured Recreational and Cultural Activities
- Improved Engagement and Marketing

Considerations Going Forward



- Expanding Involvement with Other Cities, Community Based Organizations (CBO's), and Stakeholders
- Review 3rd Party Permits, Licenses on School Sites
- Distribution of CSP Sites to Ensure Geographic Equity
- Overlay of RAP Priorities and LAUSD Priorities
- Ability to Identify Funding to Enhance Viability/Success of the Program
- RAP Ability to Staff the Program, Including Supervisory Structure

Next Steps for LA City – LAUSD



- LAUSD and City Enter Into a Joint Powers Agreement (JPA) to Support CSP Program
 - Provides All of the Terms and Conditions for Use by RAP of LAUSD Schools
 - Confirms Costs RAP Will Cover – No Cost to LAUSD
 - Provides for Process to Identify Schools and Resolve Disputes, if any
 - Flexible Master Agreement Allowing Sites to be Added or Removed Depending on Viability of Programming, Ability to Staff and Funding at Each Site
- Seek BOE and City Council Approval in Q1 2024
