SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. Upon release of the legislative budget in early April 2021, the district began discussing our anticipated allocation and allowable uses for these funds at public budget meetings. District administration engaged in discussions about plan development, using data to discuss how these funds could best serve the students of our District. In early June of 2021 a survey was opened up on the District website inviting feedback from district staff, parents and community members. This survey along with information about the allowable uses of funds and our initial plan ideas was posted on our website and sent out to the community in an email blast. The survey was open through the end of June. The District also held a zoom meeting with various stakeholders including parents, teachers, administration and community members. We also had a meeting with student representatives to discuss the plan. *We will meet again with stakeholder groups before the start of the new school year (in late summer) to discuss the ARP plan. We also continue to discuss the ARP plan and use of funds at public board meetings.*

Part of our grant will be used to create and fund a new stipend for a Covid-19 Coordinator. This position, In coordination with the Superintendent and School District Physician, will be responsible for ensuring the District meets its obligations under federal, state and local mandates and guidelines related to COVID 19 including but not limited to tracking vaccination information, and conducting and/or overseeing contact tracing, COVID19 testing and/or COVID19 screening as well as other duties and responsibilities related to the District's response to the COVID 19 pandemic.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

In order to track student progress, we are using a new benchmarking system. This year we are implementing i-Ready with all students in grades K through 8. In addition we are tracking the attendance data, discipline data, and other forms of perception data. This includes a Panorama school climate survey. In the high school, we will continue to track school-wide measures such attendance and discipline. We are also closely monitoring report card grades and test scores to ensure progress

- 5. A. New Interventionist position In the 2021-22 school year, some students will need to be remote for periods of time due to quarantine. Students in the elementary classroom or school will be assigned to temporary remote learning to prevent learning loss. When students need temporary remote instruction, teachers will consult with the interventionist and will have access to the same instruction as their classmates and all core subjects. There will also be time with the interventionist to help students who are struggling with the effects of quarantine on academics

B. After School Learning Center for TMS/THS

The TMS/THS After-School Learning center will take place on Mondays, Tuesdays, and Thursdays at the TMS/THS after school. Students will be recommended for a determined number of days for the Learning Center by building administration in consultation with teachers and support staff. Students who attend the Learning Center will be invited on days when there is a tutor who can support them. For example, if a reading tutor has an opening on Mondays and Thursdays, the student would be assigned to the Learning Center on those afternoons. Enrollment and participation in the program will depend on availability of tutors.

- Students in grades 6-8 can receive tutoring in reading and math.
- Students in grade 8 can receive tutoring in earth science and algebra.
- Students in grades 9-12 will be connected with tutors in the major content areas.

While the Learning Center is not designed for homework support, students may work on projects and assignments with their tutors. Tutors will be given an overview of the student and their needs, including a strengths and needs assessment from the teacher and, if available, their i-Ready diagnostic data. In the instance where an on-site tutor is not available for a subject area, the program coordinator will contract with an outside agency to provide remote tutoring during the Learning Center operational hours. At the end of the student's recommended time in the program, the program coordinator will work with the administrator to determine next steps: whether the student is to continue with the program. The coordinator will ask for a summary of work and progress on behalf of the tutor and share with the building administrator.

C.

1. William E. Cottle Elementary School After-School Learning Center

The WEC After-School Learning center will take place on Mondays, Tuesdays, and Thursdays at WEC after school. Students will be recommended for a determined number of days for the Learning Center by building administration in consultation with teachers and support staff. Students who attend the Learning Center will be invited on days when there is a tutor who can support them. For example, if a reading tutor has an opening on Mondays and Thursdays, the student would be assigned to the Learning Center on those afternoons. Enrollment and participation in the program will depend on availability of tutors.

While the Learning Center is not designed for homework support, students may work on projects and assignments with their tutors. Tutors will be given an overview of the student and their needs, including a strengths and needs assessment from the teacher and their i-Ready diagnostic data. The focus of a tutor's work will be on reading and math.

At the end of the student's recommended time in the program, the program coordinator will work with the administrator to determine next steps: whether the student is to continue with the program. The coordinator will ask for a summary of work and progress on behalf of the tutor and share with the building administrator.

We anticipate the entire allocation of the ARP ESSER 2 funds will be used for the covid coordinator, interventionist, quarantine teacher & tutoring.
