**AMENDMENT TO THE FACILITIES SERVICES STRATEGIC EXECUTION
PLAN TO APPROVE A WATER CONSERVATION PROGRAM**

WHEREAS, District Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to approve a Water Conservation Program at school sites throughout the District for a total program budget of \$5 Million; and

WHEREAS, The Facilities Services Division began executing water conservation upgrades at multiple schools throughout the District in the first quarter of 2013 using Residual Special Reserve non-bond funds; and

WHEREAS, Approval of this action would allow the bond program to reimburse the Residual Special Reserve funds originally expended and continue the water conservation program at school sites throughout the District; and

WHEREAS, Construction at 32 sites was began in the first quarter of 2013 and work at 19 of those sites has been completed, while work at all 32 sites and all additional sites executed under this program are expected to be completed by the fourth quarter of 2018; and

WHEREAS, These water conservation upgrades include replacing older inefficient water closets (toilets) and urinals with modern water closets and urinals that consume significantly less water as well as any necessary improvements to the plumbing system to ensure maximum performance of these new water fixtures; and

WHEREAS, At the 32 sites with work completed or in progress, a total of 3,324 water closets and 924 urinals will be replaced and, altogether, this program is expected to replace approximately 6,500 older inefficient water closets and approximately 2,000 older inefficient urinals leading to an annual reduction in District water consumption of approximately 100 Million gallons; and

WHEREAS, Water conservation upgrades will be prioritized at those District schools with the largest number of inefficient fixtures; and

WHEREAS, The Special Residual Reserve funds that will be reimbursed as part of this action is primarily funded from interest earned from Certificates of Participation and certain grants, and is used to fund capital projects and also sometimes used for cash flow purposes, such as front-funding capital projects that ultimately are funded from a different source; and

WHEREAS, The reimbursed Residual Special Reserve will in turn make debt service payments on the District's Certificates of Participation ("COPs"), payments that otherwise would be made out of the District's General Fund and this will result in an equivalent amount of General Fund savings to the District; and

WHEREAS, Surveys of the fixtures at the school sites listed on Attachment A will be conducted and those sites with the largest number of inefficient fixtures will be addressed first and this work will continue at as many school sites as the \$5 Million funding allocation permits; and

WHEREAS, These upgrades will also enable the District to reduce its annual water consumption by approximately 100 Million gallons and avoid approximately \$1 Million annually in General Fund costs for water; and

WHEREAS, The Facilities Services Division will report on progress of this program in the Strategic Execution Plan on an annual basis; and

WHEREAS, \$5 Million of Bond Program funds earmarked specifically for critical school repair and safety improvements to school building components will be allocated to water conservation upgrades at school sites throughout the District; and

WHEREAS, \$2,326,740 of these bond funds will reimburse Residual Special Reserve funds resulting in an equivalent amount of General Fund savings and the remaining \$2,673,260 will fund the completion of projects currently in progress as well as future work at sites to be identified from those listed in Attachment A; and

WHEREAS, It is anticipated that these upgrades will reduce the District's annual water consumption by approximately 100 Million gallons and avoid approximately \$1 Million in annual General Fund costs for water; and

NOW, THEREFORE, BE IT RESOLVED THAT:

BOARD REPORT

- Action Proposed:** Staff proposes that the Board of Education approve an amendment to the Facilities Services Division (FSD) Strategic Execution Plan (SEP) to approve a Water Conservation Program at school sites throughout the District (potential sites are listed in Attachment A) for a total program budget of \$5 Million.
- Background:** The Facilities Services Division began executing water conservation upgrades at multiple schools throughout the District in the first quarter of 2013 using Residual Special Reserve non-bond funds. Approval of this action would allow the bond program to reimburse the Residual Special Reserve funds originally expended and continue the water conservation program at school sites throughout the District. Construction has begun at 32 sites and has been completed at 19 of those sites (Attachment B). Construction started in the first quarter of 2013 and is expected to be complete at these 32 sites and all additional sites executed under this program in the fourth quarter of 2018.
- These water conservation upgrades include replacing older inefficient water closets (toilets) and urinals with modern water closets and urinals that consume significantly less water as well as any necessary improvements to the plumbing system to ensure maximum performance of these new water fixtures.
- At the 32 sites with work completed or in progress, a total of 3,324 water closets and 924 urinals will be replaced. Altogether, this program is expected to replace approximately 6,500 older inefficient water closets and approximately 2,000 older inefficient urinals leading to an annual reduction in District water consumption of approximately 100 Million gallons.

Water conservation upgrades will be prioritized at those District schools with the largest number of inefficient fixtures.

The Special Residual Reserve funds that will be reimbursed as part of this action is primarily funded from and interest earned from Certificates of Participation and certain grants, and is used to fund capital projects. The Residual Special Reserve is also sometimes used for cash flow purposes, such as front-funding capital projects that ultimately are funded from a different source. The reimbursed Residual Special Reserve will in turn make debt service payments on the District's Certificates of Participation ("COPs"), payments that otherwise would be made out of the District's General Fund. This will result in an equivalent amount of General Fund savings to the District.

Expected Outcomes: If the Board of Education approves staff's proposal, surveys of the fixtures at the school sites listed on Attachment A will be conducted and those sites with the largest number of inefficient fixtures will be addressed first. This work will continue at as many school sites as the \$5 Million funding allocation permits.

These upgrades will also enable the District to reduce its annual water consumption by approximately 100 Million gallons and avoid approximately \$1 Million annually in General Fund costs for water. The upgrades began in Q1 2013 are expected to be complete in Q4 2018.

On an annual basis the Facilities Services Division will report on progress of this program in the Strategic Execution Plan.

Board Options and Consequences: A "yes" vote will allow the Facilities Services Division to move forward with the Water Conservation Program and enable the District to reduce annual water consumption by approximately 100 Million gallons and avoid approximately \$1 Million in annual General Fund costs for water.

If the proposed action is not approved, this program will be discontinued, the Residual Special Reserve funds will not be reimbursed for work already completed, and reimbursed Residual Special Reserve funds will not be used for debt service payments on COPs, currently planned for payment from the General Fund.

Policy Implications: These actions are consistent with the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment.

Budget Impact:

If this item is approved, \$5 Million of Bond Program funds earmarked specifically for critical school repair and safety improvements to school building components will be allocated to water conservation upgrades at school sites throughout the District.

\$2,326,740 of these bond funds will reimburse Residual Special Reserve funds resulting in an equivalent amount of General Fund savings. The remaining \$2,673,260 will fund the completion of projects currently in progress as well as future work at sites to be identified from those listed in Attachment A.

It is anticipated that these upgrades will reduce the District's annual water consumption by approximately 100 Million gallons and avoid approximately \$1 Million in annual General Fund costs for water.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizens' Oversight Committee ("BOC") at its meeting on April 30, 2015. Staff has concluded that the proposed amendment to the FSD-SEP will help facilitate implementation of the SEP, and therefore, it will not adversely affect the District's ability to successfully complete the SEP.
