Data for TSD per Board of Education Report dated 8/24/21 on Update to the School Upgrade Program to Integrate Measure RR Funding and Priorities with data dated 6/30/21 and subsequently updated per Board of Education Report adopted 12/7/21.
- 2) Spending Target is the Board-approved allocation of funds available for each category. It includes Board action to integrate Measure RR on 8/24/2021 and other actions that modified the amount available for projects since the inception of the SUP approved by the Board in January 2014. Allocations to indirect costs and program reserve, which were \$1,044,905,000 for Measure RR, have been deducted from the spending target. When the BOC recommends a project, it recommends an allocation of funds from the spending target toward a project budget. However, ultimately it is the Board's responsibility to approve projects and budgets. The spending target is primarily funded by bond measures though includes other sources such as interest earnings, State funds, developer fees, etc.
- 3) Allocation available can change monthly based on new projects being approved as well as updates to the budget on existing projects previously approved. More specifically, the budget is the expenditure estimate at completion (EAC), which may be updated as a project progresses.
- 4) Board Member and Local District Priority categories have a high percentage remaining because funds for these priorities pre-date the SUP and are allocated over a long-term timeframe.

Major Modernizations	Major modernizations anticipated at seven schools. These multi-phased projects may include some or all of the following, but are not limited to, addressing earthquake safety (seismic retrofit, seismic modernization and/or replacement) providing 21st century general and specialty classrooms, upgrading accessibility, removing/replacing relocatable buildings, addressing failing building systems and grounds, landscape upgrades, physical security upgrades, and various site upgrades.	+/- \$840M	Sites deemed to be in the greatest need based on an assessment of 10 weighted facilities-based datasets that best express a school’s physical condition. Each Board Member selects one site from the top 10 percent of sites with the greatest need. Ms. Greene called the meeting to order at 10:07 a.m.

00:00:06 Chair's Remarks

Ms. Greene chaired the meeting and welcomed all to the Bond Oversight Committee (BOC) meeting. She stated that this was the last meeting of the school year. She asked BOC members participating remotely to set their Interpretation Feature on the Zoom screen menu to their preferred language for simultaneous interpretation. She also thanked the KLCS staff for their production, Spanish Interpretation staff for their work in translating and other District Staff for their assistance in broadcasting this hybrid BOC meeting.

Ms. Greene indicated that District Staff and members of the public, who were not present in the Board Room, could watch the meeting via the BOC website www.lausd.org/bond by clicking on the live stream feature under the "Meeting Agendas" tab.

Ms. Greene stated that the hybrid meeting was being conducted in accordance with the requirements of the Brown Act that governs public meetings of legislative bodies. She informed that two of the three teleconference locations posted on the agenda

were not available for remote participation because the members identifying those locations in advance of the meeting were not able to attend. She explained that public speakers were asked to sign up using a hyperlink to a Google form included on the agenda **and posted to the BOC's website on May 27, 2022**. She stated that the form was available 24 hours before the start of the meeting and would remain open for 20 minutes after the start of the meeting.

Ms. Greene indicated that there would be a maximum of five (5) speakers for each agenda item and up to ten (10) speakers for general public comment. She stated that all public speakers would have up to 3 minutes and would be heard on phone/audio only. She also stated that public speakers with more than one agenda item would be provided 6 minutes total to make comments on all items they wished to address. She detailed the protocols for public speakers via audio and said that they should monitor the meeting through the live stream and then turn off the live stream volume when asked to speak to avoid audio echo or audio feedback. When it was **the speaker's** turn to speak, Ms. Zitle would announce the last four digits of **the caller's** phone number, and each public speaker would be instructed to unmute on Zoom, or press *6 (star 6), to speak. She stated that in-person speakers would be asked to step up to the podium to be heard. She thanked everyone in advance for working with the Committee to accommodate speakers.

Ms. Greene read the Bond Oversight Committee's (BOC) mission statement:

"The mission of the Oversight Committee is to oversee the permissible and prudent expenditure of funds for the construction, repair, and modernization of schools by the Los Angeles Unified School District (LAUSD). In order to effectively carry out that mission the Oversight Committee must remain strong and independent. That is our responsibility to the District, the teachers, the students, and the taxpayers."

Ms. Greene recognized the participation of a BOC member at a ribbon-cutting ceremony. On May 26, BOC member Margaret Fuentes, LAUSD Student Parent, attended the ribbon-cutting ceremony at Fremont High School. Ms. Fuentes shared brief remarks about her experience. Ms. Greene stated that, on May 20, she attended and spoke at the ribbon-cutting ceremony for the Eagle Rock High School Auditorium renovation project, which included a student production of *Spamalot* as part of the celebration. She indicated that photos of the events were posted on the BOC website. Ms. Greene provided brief remarks about the event.

Ms. Greene announced that the annual election of BOC Officers and BOC Executive Committee appointments would take place during the meeting.

Vice Chair Mr. Hannan asked Ms. Greene to go down to the podium to join Deputy Superintendent Megan Reilly, who began **the presentation by praising Ms. Greene's work and for** her service on the BOC. Ms. Reilly emphasized the partnership and relationship built between the District and the Committee during those years through integrity, questioning and scrutiny that Ms. Greene exemplified in her role of parent, professional and Chair. She also reminded the audience of some accomplishments achieved over this period: the approval of local bond Measure RR by approximately 70 percent of voters, 19,000 school sites modernization projects approved and/or completed while managing the program through wildfires, other climate change issues and COVID. She also highlighted the many security and safety projects that were prioritized in the bond program to protect **LAUSD students. She concluded by thanking the BOC and Ms. Greene's leadership** for working as partners with the District to allow the enablement of projects to become a reality through the bond program.

Ms. Greene was presented a framed certificate of appreciation from the Superintendent and the Board of Education that was read by Mr. Hannan. Other BOC members shared words of gratitude and appreciation for **Ms. Greene's** kindness, commitment, guidance and skillful inquiry as the Chair of the BOC.

Ms. Greene, as part of her parting remarks, stated her gratitude and honor to having served on the BOC. She thanked District staff, BOC staff and BOC members for their support of bond program oversight. She stated: "...many think of the bond program only as something to do with taxes. But **it's much more than that. It's a connection. It's a glue that we use to repair. It's a link that we feel with others. It's a promise. It's an oath. It's a commitment from us to the future.**" She said that she hoped the District will see any decrease in enrollment as an opportunity to repurpose potential surplus land, and within permissible mandates, to help address concerns affecting LAUSD stakeholders. She concluded by thanking everyone for their support.

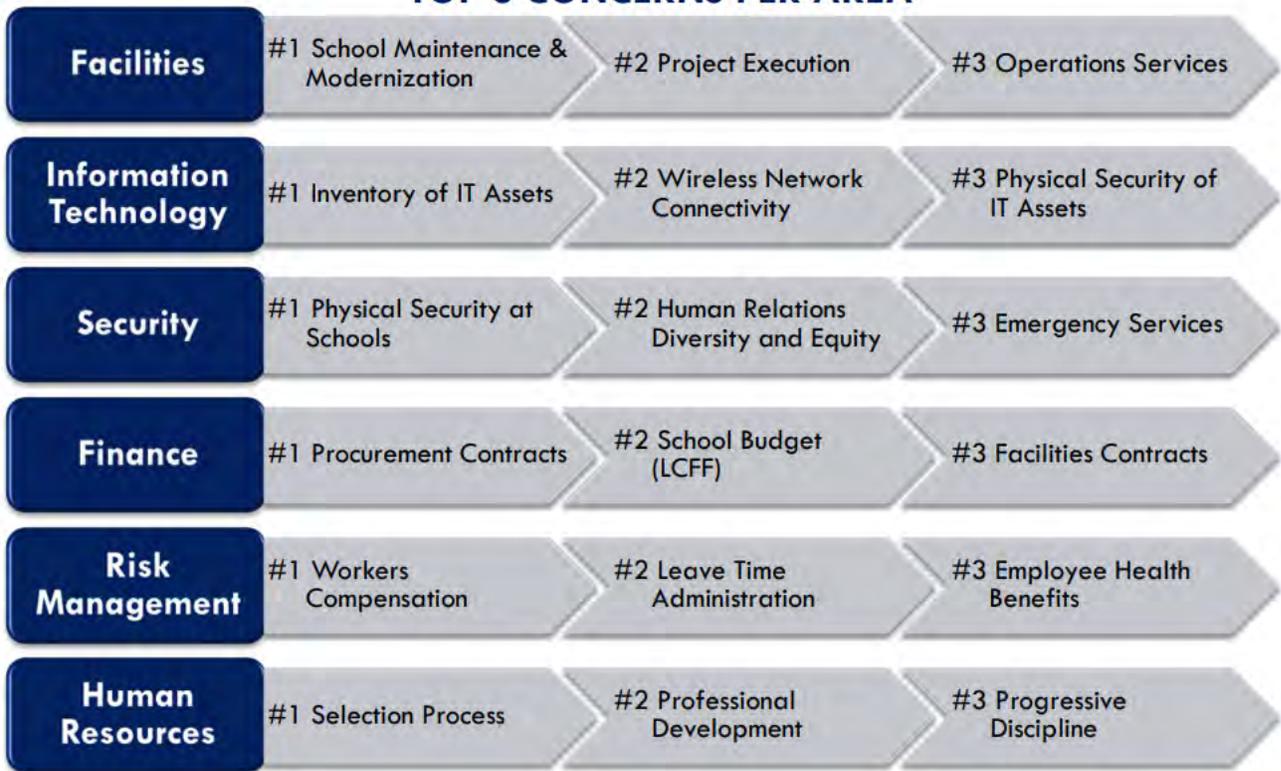

Presenter: Salvatore Randazzo, Interim Inspector General, OIG

[Scott Pansky left the meeting at 11:26 a.m.]

Mr. Randazzo began his presentation stating that Mr. Onwualu, Deputy Inspector General, was also in attendance to address questions. Mr. Randazzo **presented the Inspector General's (OIG) FY22 Work Plan that incorporated** an audit plan of bond funded contracts and bond related activities and programs of ongoing and future work that involves the performance of due diligence reviews and investigations. He reported that 161 responses from a survey to stakeholders were factored into a comprehensive risk assessment to develop the annual work plan. He explained how **the OIG's office categorized the top** three areas of concern and provided examples of planned work.

SURVEY RESPONSES TOP 3 CONCERNS PER AREA



Mr. Randazzo stated that the total contract value of \$587M included 45 projects within the types of audits below as well as five technical evaluations. He presented a proposal in the amount of \$5M from the School Upgrade Program (SUP):

- Incurred Cost Audits: 27 projects - This type of audit examines the actual costs incurred by the contractor to determine whether the costs were allowable, allocable and reasonable in accordance with the Federal Acquisition Regulation (FAR) and contract terms. to verify the appropriate amount of money per contract. All questions were answered by Mr. Randazzo.
- Performance Audits: 16 projects - This type of audit is an objective and systematic examination of evidence for the purpose of providing an independent assessment of the performance of an organization, program, activity, or function in order to determine if it is performing efficiently and effectively and in compliance with policies, procedures, laws and regulations.
- Special Reviews: 1 project - Special reviews are conducted as a result of requests from the Board of Education, District Management, findings identified in the course of an audit, or concerns reported to the OIG. The reviews are limited in scope and address the specified concerns only. They are not conducted in accordance with Generally Accepted Government Auditing Standards (GAGAS).
- Change Order Audits: 1 project - This audit examines the contract change order for allowability, allocability and reasonableness of the proposed or claimed change order costs. This includes changes due to added or deleted work, equitable adjustments for delay, disruption, inefficiencies, contract terminations and other claims. The OIG also performs audits of construction change orders based on management requests.
- Rate Reviews: TBD - This type of review examines **an existing contractor's actual direct labor and overhead rates in order to** assist Procurement officials with determining the reasonableness of provisional billing rates. These reports are not published.

- Technical Evaluations: 5 projects - Technical Evaluations are tests or studies conducted to determine the technical suitability of a structure, equipment, material, product, process or system for the intended objectives. Completed projects will be evaluated to ensure compliance with contract documents, specifications, and State Code requirements.

There was a question related to frequency of reports received via the OIG Hotline.

Presenters: Krisztina Tokes, Deputy Chief Facilities Executive, FSD
Dr. Douglas Meza, Administrator of Operations, Local District West

Ms. Tokes, Deputy Chief Facilities Executive, jointly with Dr. Meza, Administrator of Operations of Local District West, presented the Richland Campus reconfiguration project and amendment to the Facilities Services Division Strategic Execution Plan. Ms. Tokes provided information about the French dual immersion program that was initiated in 2014 and has reached capacity after eight years of steady growth. She said that projections indicate that the middle school grades sixth through eighth would add approximately 150 students to this program. She explained the upgrades and alterations required as part of the scope of work for the proposed project to install four portable classroom buildings, refurbish the existing restroom facilities, repair paving, provide solar reflective coating as well as a small quad for students. The total budget was \$10.8M. The project was scheduled to begin in the third quarter of 2024 and end in the third quarter of 2025. Please refer to Board Report No. 300-21/22 for further detailed information.

Mr. Meza stated that the French immersion program aligns with the Global California 2030 initiative encouraging students to participate in language education at K-12 schools by 2030 to reach proficiency in two or more languages and earn a State Seal of Biliteracy by 2040. He informed that the initiative is supported by research on dual language programs showing benefits in the social, cultural and cognitive areas. He shared key findings that resulted from a study conducted by the Rand Corporation and the American Councils for International Education. He also presented a map of Dual Language program locations for the school year 2022-2023 by Local District - totaling 218. He highlighted some of the benefits that the proposed program would provide such as small classes, high pass rate of the **Diplôme d'Etudes en Langue Française**, recruitment from other districts and private schools, and increase in enrollment that provides additional funding.

Discussion included compliments regarding the positive benefits of dual language programs. BOC members also asked about a detailed cost breakdown of the project, the number of permanent buildings that would be utilized or not on the campus for this program, whether the school expansion projections were based on current enrollment, what the process was to identify locations to implement a dual immersion program, suggestions as to raising parental awareness about incorporating dual language programs in schools, what the overall assessment was for the need for other programs to increase capacity resulting in the reallocation of assets from other sites with decreased capacity, the impact to other middle schools in the neighborhood, and concern about whether the end product was an appropriate investment when considering its lifespan.

Ms. Tokes and Dr. Meza answered all questions.

Presenter: Monica Nolen, Director of IT, Project Management, ITD

Ms. Nolen presented updates on three active projects as part of the IT BOC Quarterly Report for the first quarter in 2022 that covers January 1, 2022 through March 31, 2022.

Disaster Recovery and Business Continuity (DRBC) – This project will ensure that the District has the ability to maintain critical applications and technologies during and after an emergency. She reported that the Cloud Disaster Recovery Solution (Cloud DR) project team completed the kick-off meeting with an extension in schedule from Q2 2022 to Q2 2023 for implementation. No additional budget is required due to the timeline extension.

Enterprise Help Desk – She said that the new system would be released to parents and community members via LAUSD mobile app **in alignment with the District's** Strategic Plan and has been rescheduled for completion from Q1 2022 to Q2 2022, which would include Service Catalog, Problem Management and Virtual Agent components.

Radio System Modernization – This project **will modernize the District's radio system by replacing obsolete infrastructure and creating** a single unified system for improved communications for schools, school police, transportation and emergency operations. She stated that after an introductory feasibility study and discovery phase, the project will need a project schedule extension from Q3 2023 to Q2 2024.

School Network Systems Upgrade Project, Phase 1 (262 sites) – This project will replace obsolete, end-of-life, and public address equipment to modernize telecommunication systems and replace security systems. She reported that the project timeline was extended from Q2 2025 to Q2 2026 because of supply chain issues.

Telecommunications and Network Upgrades at 83 Schools – **This project will update the District's failing and obsolete telephone,** network, and public address systems and equipment at 83 schools. She indicated that project team exceeded its target this quarter by completing two additional schools for a total of 72 sites with upgraded Wireless Local Area Network (WLAN), Local Area Network (LAN), VoIP phone system and PA system. Due to supply chain issues, the project requires a timeline extension from Q2 2022 to Q1 2023. There is no resulting impact to the budget.

Wireless Network Equipment Upgrade Project (160 Schools) – This project will replace the **District's** failing and obsolete wireless systems and equipment at 160 schools. She stated that the project team completed 126 sites – just slightly under the goal of completing

132 schools thus far. She also said that the global supply chain delay also impacted this project and that it would require an extension from Q2 2022 to Q2 2023. One school was removed from the project list bringing the project down to 159 school sites and funding from that one project will be returned to the ITD SUP category.

There was a question regarding close-out reports to reflect the final number of schools and budget for the Wireless Network Equipment Upgrade Project and clarification of the difference between the School Network Systems Upgrade Project and the Telecommunications and Network Upgrades.

IX. LAUSD Bond Program Status: School Upgrade Program (SUP)

The District bond program is composed of multiple “managed programs” funded by District Bond Measures BB (1997), K (2002), R (2004), Y (2005), Q (2008), RR (2020) and state bond funds and developer fees.

On November 3, 2020, voters approved Measure RR allocating an additional \$7 billion for the LAUSD bond program. On August 24, 2021, the Board of Education approved the implementation of Measure RR funding and priorities into its operational framework.

The current managed program is the Updated School Upgrade Program (SUP) adopted by the Board of Education on August 24, 2021. The Updated SUP is composed of 16 program categories, known as “spending targets,” with a total budget of approximately \$13.7 billion.¹ The Updated SUP is primarily funded by District Bond Q and RR. The majority of SUP projects, approximately \$12 billion, or 88% of the total SUP budget, is managed by the Facilities Services Division (FSD).²

Specific bond program projects are included in the SUP where funds are available within spending targets and after they are approved by the Board of Education. Projects (scope, schedule and budget) are proposed as Strategic Execution Plan (SEP) amendments. Proposed projects are first considered by the BOC for recommendation, and then presented to the Board of Education for approval.

FSD Quarterly Program Expenditures and Change Order Rate:

- Total quarterly FSD bond fund expenditures by month: April 2022 - \$82.9M, May 2022 - \$88.5 and June 2022 was not available at time of publication of this report.
- As of June 15, 2022, the cumulative change order rate for all project types was 12.33%.

Legacy programs include the Capital Improvement Program (CIPR), the New Construction Program, the Modernization Program and the BB Program. The majority of projects included in legacy programs have achieved substantial completion, been closed out, reassigned to other managed programs, or remain active only for the purpose of resolving outstanding claims or other administrative or legal issues.

² Bond program projects are managed in the LAUSD organization according to project type and staff expertise in the following divisions: Facilities Services Division (FSD), Information Technology Division (ITD), Transportation Services Division (TSD), Chief Financial Officer (CFO) and Office of the Inspector General (OIG).

Facilities Services Division

Action Proposed:

Define and approve 31 Board Member Priority (BMP) and Local District Priority (LDP) projects, as listed on Attachment A, and amend the Facilities Services Division (Facilities) Strategic Execution Plan (SEP) to incorporate therein. The total budget for these projects is \$1,780,794.

Authorize the Chief Procurement Officer and/or the Chief Facilities Executive and/or their designee(s) to execute all instruments necessary, as legally permissible, to implement the proposed projects, including budget modifications and the purchase of equipment and materials.

Background:

Projects are developed at the discretion of the Board Districts and/or Local Districts based upon an identified need. These projects are developed with support from Facilities Services Division staff and input from school administrators.

Project scopes, schedules, and budgets may vary depending on site conditions and needs. All projects must be capital in nature and adhere to bond language and laws.

Expected Outcomes:

Execution of these projects will help improve the learning environment for students, teachers, and staff.

Board Options and Consequences:

Adoption of the proposed action will allow staff to execute the projects listed on Attachment A. Failure to approve this proposed action will delay the projects and ultimately the anticipated benefit to the school and its students.

Policy Implications:

The requested actions are consistent with the Board-Prioritized Facilities Programs for BMP and LDP projects and the District's commitment to address unmet school facilities needs and provide students with a safe and healthy learning environment.

Budget Impact:

The total combined budget for the 31 projects is \$1,780,794. Four projects are funded by Bond Program funds earmarked specifically for LDP projects. Twenty-seven projects are funded by Bond Program funds earmarked specifically for BMP projects.

Each project budget was prepared based on the current information known and assumptions about the project scope, site conditions, and market conditions. Individual project budgets will be reviewed throughout the planning, design, and construction phases as new information becomes known or unforeseen conditions arise and will be adjusted accordingly to enable the successful completion of each project.

Student Impact:

The projects proposed in this Board Report will upgrade, modernize, and/or improve school facilities to enhance the safety and educational quality of our students' learning environment.

Issues and Analysis:

This report includes a number of time-sensitive, small to medium-sized projects that have been deemed critical by Board Members and/or Local Districts and school administrators.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizen's Oversight Committee (BOC) at its meeting on August 11, 2022. Staff has concluded that this proposed Facilities SEP amendment is in alignment with BOC recommendations and will facilitate Los Angeles Unified's ability to successfully implement the Facilities SEP.

Define and Approve 127 Projects to Provide Critical Replacements and Upgrades of School Building/Site Systems and Components and Amend the Facilities Services Division Strategic Execution Plan to Incorporate Therein

August 30, 2022

Facilities Services Division

Action Proposed:

Define and approve 127 projects to provide critical replacements and upgrades of school building/site systems and components, as listed on Attachments A and B, and amend the Facilities Services Division (Facilities) Strategic Execution Plan (SEP) to incorporate therein. The total combined budget for the 127 projects is \$73,069,993.

Authorize the Chief Procurement Officer and/or the Chief Facilities Executive and/or their designee(s) to execute all instruments necessary, as legally permissible, to implement the proposed projects, including budget modifications and the purchase of equipment and materials.

Background:

Priorities for the expenditure of capital funding are evaluated to ensure the District's most pressing priorities are being addressed. More than 70 percent of Los Angeles Unified School District (Los Angeles Unified or District) school buildings were built more than 50 years ago, and more than \$50 billion of unfunded school facilities needs have been identified Districtwide, and these needs grow every year. As the District's capital needs far exceed available funding, the most pressing unfunded critical needs will continue to be addressed based on an evaluation of known facilities conditions and needs at schools. Projects developed under this category of need, Critical Replacements and Upgrades of School Building/Site Systems and Components, will replace failing building systems that create safety concerns and are disruptive to school operations. Systems in the worst condition, especially those that pose a safety hazard and/or will negatively impact school operations and other building systems if not addressed, will be addressed first.

The project proposals contained in this Board Report align with these priorities. Attachment A includes seven projects to replace failing building systems that create safety concerns and are disruptive to school operations. Attachment B includes 120 projects to provide new secure entry systems.

Expected Outcomes:

Staff anticipates that the Board of Education will define and approve 127 projects that address critical replacement and upgrade needs and amend the Facilities SEP to incorporate therein. Approval will authorize staff to proceed with the implementation of the proposed projects to improve student health, safety and educational quality.

Board Options and Consequences:

Adoption of the proposed action will authorize staff to proceed with the expenditure of Bond Program funds to undertake the project proposals in accordance with the provisions set forth in Los Angeles Unified local bond

measures K, R, Y, Q, and RR. If the proposed action is not approved, Bond Program funds will not be expended, and critical replacement and upgrade needs will remain unaddressed.

Policy Implications:

The proposal is consistent with the Los Angeles Unified’s long-term goal to address unmet school facilities needs and significantly improve the conditions of aging and deteriorating school facilities as described in Los Angeles Unified local bond measures. Moreover, the proposed secure entrance projects support the *Protecting Our Students and School Sites* Board Resolution (Res-032-17/18).

Budget Impact:

The total combined budget for the 127 projects is \$73,069,993. The projects will be funded with Bond Program funds earmarked specifically for critical replacements and upgrades of school building/site systems and components.

Each project budget was prepared based on the current information known and assumptions about the project scope, site conditions, and market conditions. Individual project budgets will be reviewed throughout the planning, design, and construction phases as new information becomes known or unforeseen conditions arise and will be adjusted accordingly to enable the successful completion of each project.

Student Impact:

Approval of the proposed projects enables the District to continue our ongoing efforts to undertake facilities improvements that help ensure students are provided with safe school environments that promote teaching and learning.

Issues and Analysis:

It may be necessary to undertake feasibility studies, site analysis, scoping, and/or due diligence activities on the proposed projects prior to initiating design. As necessary, the Office of Environmental Health and Safety (OEHS) will evaluate the proposed projects in accordance with the California Environmental Quality Act (CEQA) to ensure compliance. If through the planning and design process it is determined that the proposed project scope(s) will not sufficiently address the critical needs identified, the project scope, schedule and budget will be revised accordingly.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizen’s Oversight Committee (BOC) at its meeting on August 11, 2022. Staff has concluded that this proposed Facilities SEP amendment is in alignment with BOC recommendations and will facilitate Los Angeles Unified’s ability to successfully implement the Facilities SEP.

Projects to Replace Failing Building Systems that Create Safety Concerns and are Disruptive to School Operations

- 1. Chatsworth Charter High School – Project to Provide New Heating, Ventilation, and Air Conditioning Systems**
 - *Local District Northwest, Board District 3 – Schmerelson*
 - *Project Background and Scope* – This project is to provide new heating, ventilation, and air conditioning (HVAC) systems campus-wide.
Project Budget -- \$52,527,074
 - *Project Schedule* – Construction is anticipated to begin in Q1 2025 and conclude in Q2 2028.

- 2. Cowan Avenue Elementary School – Project to Provide Slope Remediation and Asphalt Paving**
 - *Local District West, Board District 4 – Melvoin*
 - *Project Background and Scope* – This project is to provide new drainage, foundation, and perimeter fencing, rails and poles to prevent further slope erosion along the northwest of the main playground. In addition, the project will replace approximately 18,900 square feet of asphalt pavement on the playground, regrade for proper drainage, repair cracks, spalling, and local settlement at the pavement.
 - *Project Budget* -- \$2,957,057
 - *Project Schedule* – Construction is anticipated to begin in Q3 2024 and conclude in Q3 2025.

- 3. Robert F. Kennedy Community Schools – Project to Replace Synthetic Turf Fields**
 - *Local District Central, Board District 5 – Goldberg*
 - *Project Background and Scope* – This project is to replace approximately 72,000 square feet of synthetic turf on the soccer field, approximately 50,000 square feet of synthetic turf on the multi-purpose playfield, and replace the track around the multi-purpose playfield.
 - *Project Budget* -- \$7,632,721
 - *Project Schedule* – Construction is anticipated to begin in Q2 2024 and conclude in Q4 2025.

- 4. Clover Avenue Elementary School – Project to Provide New Roofing**
 - *Local District West, Board District 1 – McKenna*
 - *Project Background and Scope* – This project is to provide approximately 52,250 square feet of new roofing at 20 buildings, including the installation of new gutters and downspouts, and painting of affected areas.
 - *Project Budget* -- \$1,127,881
 - *Project Schedule* – Construction is anticipated to begin in Q3 2023 and conclude in Q2 2024.

- 5. Odyssey Continuation High School – Project to Provide New Roofing**
 - *Local District East, Board District 5 – Goldberg*
 - *Project Background and Scope* – This project is to provide approximately 13,200 square feet of new roofing at one building, including the installation of new gutters and downspouts, and painting of affected areas.
 - *Project Budget* -- \$328,824
 - *Project Schedule* – Construction is anticipated to begin in Q3 2023 and conclude in Q1 2024.

6. Walter Reed Middle School – Project to Provide New Roofing

- *Local District Northeast, Board District 3 – Schmerelson*
- *Project Background and Scope* – This project is to provide approximately 59,200 square feet of new roofing at 16 buildings, including the installation of new gutters and downspouts, skylights, and painting of affected areas.
- *Project Budget* -- \$1,340,124
- *Project Schedule* – Construction is anticipated to begin in Q3 2023 and conclude in Q2 2024.

7. William Howard Taft Charter High School – Project to Provide New Roofing

- *Local District Northwest, Board District 4 – Melvoin*
- *Project Background and Scope* – This project is to provide approximately 100,730 square feet of new roofing at seven buildings, including the installation of new gutters and downspouts, and painting of affected areas.
- *Project Budget* -- \$1,900,518
- *Project Schedule* – Construction is anticipated to begin in Q3 2023 and conclude in Q2 2024.

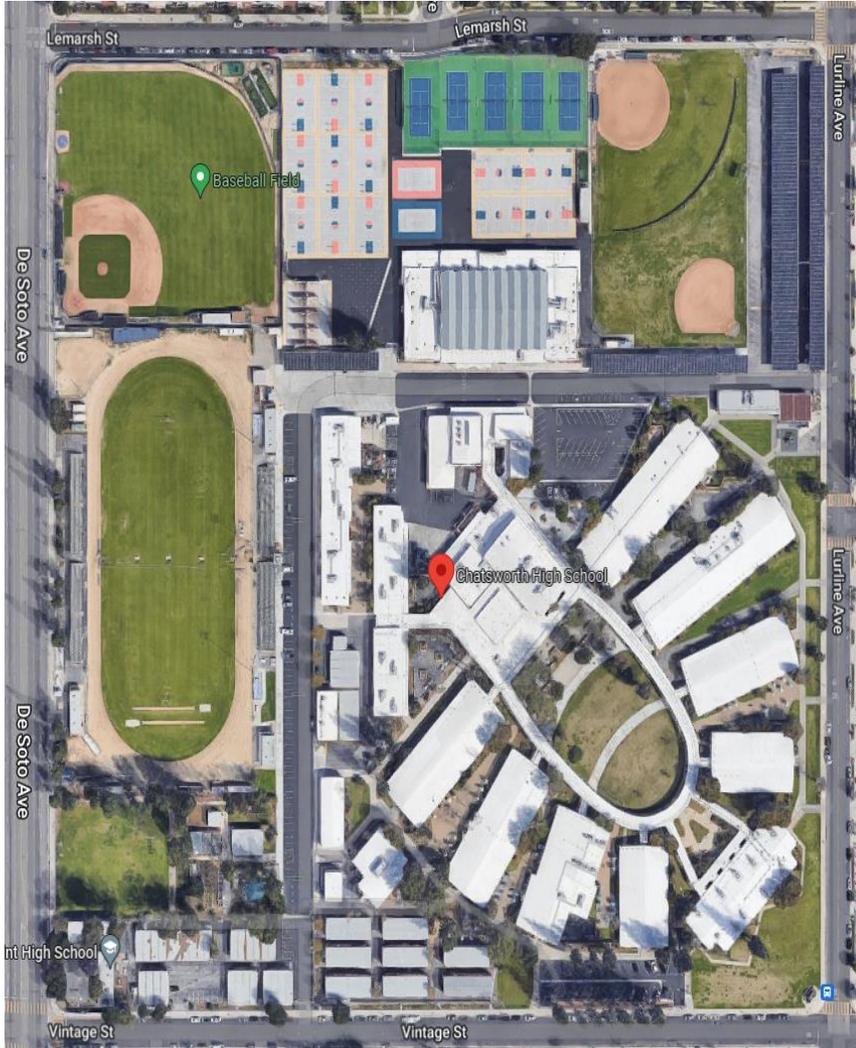

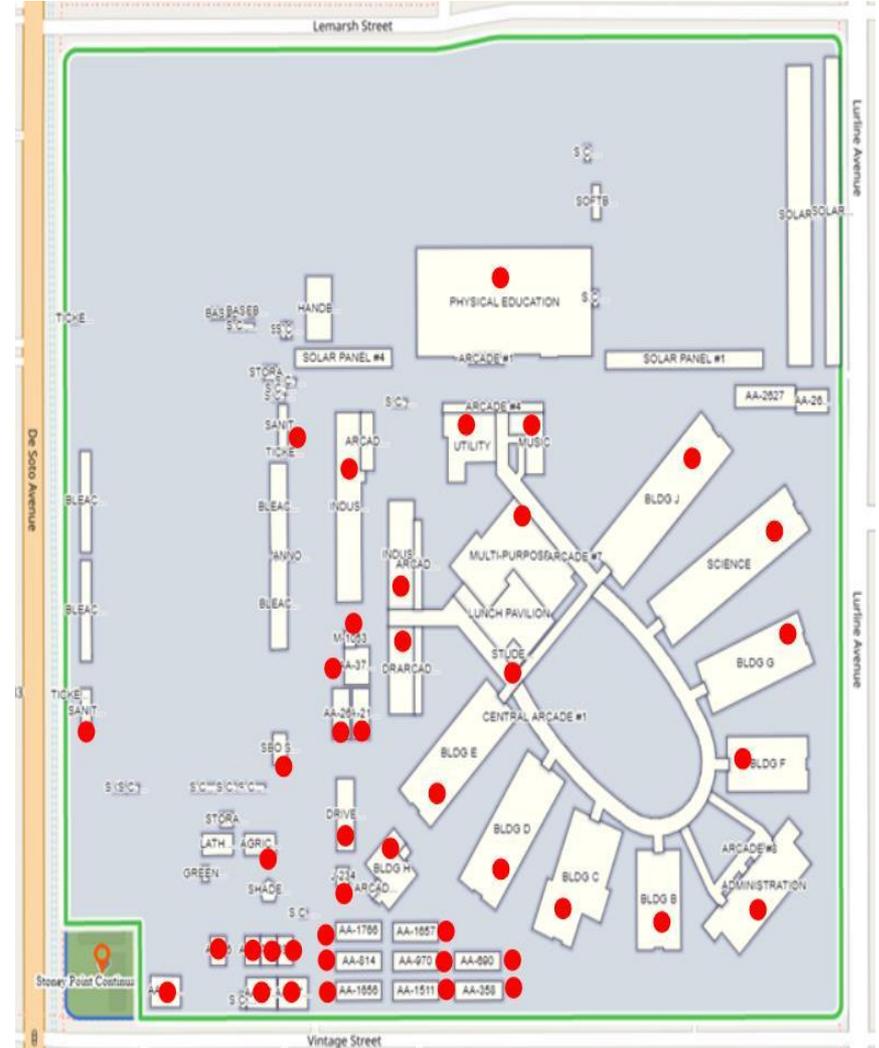

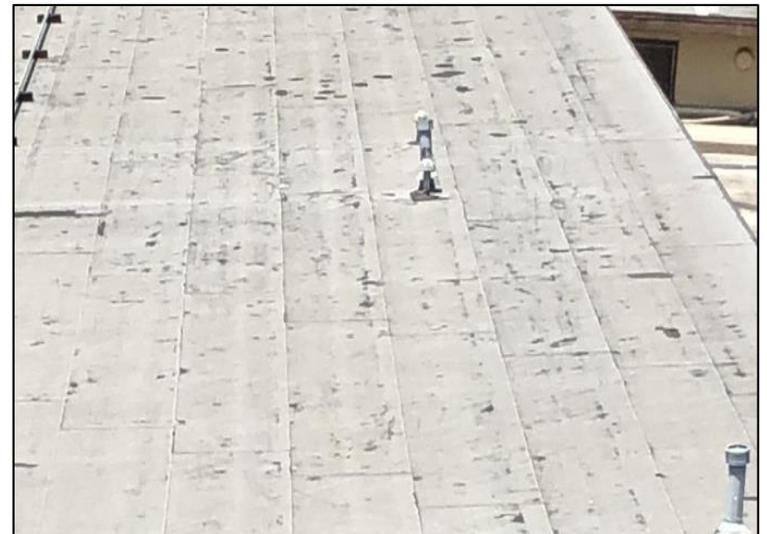

Define and Approve Nine Charter School Facilities Upgrade Projects and Amend the Facilities Services Division Strategic Execution Plan to Incorporate Therein

Facilities Services Division

Action Proposed:

Define and approve nine projects to provide upgrades for Los Angeles Unified School District (Los Angeles Unified or District) facilities currently occupied by charter schools and amend the Facilities Services Division (Facilities) Strategic Execution Plan (SEP) to incorporate therein. The total combined budget for the nine projects, as listed on Attachment A, is \$1,259,520.

Authorize the Chief Procurement Officer and/or the Chief Facilities Executive and/or their designee(s) to execute all instruments necessary, as legally permissible, to implement the proposed projects, including budget modifications and the purchase of equipment and materials.

Background:

The School Upgrade Program (SUP) - the current phase of Los Angeles Unified's Bond Program - supports the development of projects that upgrade, modernize, and replace aging and deteriorating school facilities, update technology, and address facilities inequities in order to help improve student health, safety and educational quality. The SUP includes a spending target entitled "*Charter School Facilities Upgrades and Expansions.*" Projects developed under this category of need are included in the Facilities SEP.

Charter school facilities upgrade projects developed under this category of need are subject to assessment of the conditions and needs of the school building/site systems and components of District facilities occupied by charter schools, input from the charter school community, and development of an implementation plan by District staff.

The project proposals contained in this Board Report will replace the synthetic turf football field at the El Camino Real Charter High School site and provide secure entry systems at eight other District sites occupied by charter schools. Please see Attachment A for additional details.

Expected Outcomes:

Staff anticipates that the Board of Education will define and approve nine charter school facilities upgrade projects and amend the Facilities SEP to incorporate therein. Approval will authorize staff to proceed with the implementation of the proposed projects to improve student health, safety and educational quality at District facilities currently occupied by charter schools.

Board Options and Consequences:

Adoption of the proposed action will authorize staff to proceed with the expenditure of Bond Program funds to undertake the project proposals in accordance with the provisions set forth in Los Angeles Unified local bond measures. If the proposed action is not approved, Bond Program funds will not be expended, and the school building/site system needs will remain unaddressed.

Policy Implications:

The proposal is consistent with Los Angeles Unified's long-term goal to address unmet school facilities needs and significantly improve the conditions of aging and deteriorating school facilities as described in Los Angeles Unified local bond measures. Moreover, the proposed secure entry systems projects align with the *Protecting Our Students and School Sites* Board Resolution (Res-032-17/18).

Budget Impact:

The total combined budget for the nine projects is \$1,259,520. The projects will be funded with Bond Program funds earmarked specifically for charter school facilities upgrades and expansions.

Each project budget was prepared based on the current information known and assumptions about the project scope, site conditions, and market conditions. Individual project budgets will be reviewed throughout the planning, design, and construction phases as new information becomes known or unforeseen conditions arise and will be adjusted accordingly to enable the successful completion of each project.

Student Impact:

The proposed projects continue Los Angeles Unified's ongoing efforts to undertake improvements at District facilities that help ensure students are provided with safe school environments that promote teaching and learning.

Issues and Analysis:

It may be necessary to undertake feasibility studies, site analyses, scoping, and/or due diligence activities on the proposed projects prior to initiating design. As necessary, the Office of Environmental Health and Safety (OEHS) will evaluate the proposed projects in accordance with the California Environmental Quality Act (CEQA) to ensure compliance. If through the planning and design process it is determined that a proposed project scope will not sufficiently address the critical needs identified, the project scope, schedule and budget will be revised accordingly.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizen's Oversight Committee (BOC) at its meeting on August 11, 2022. Staff has concluded that this proposed Facilities SEP amendment is in alignment with BOC recommendations and will facilitate Los Angeles Unified's ability to successfully implement the Facilities SEP.

WHEREAS, In order to ensure the long-term permanence of each SEEDS project, the school site and/or its partner organization must enter into a Maintenance Agreement that provides for the on-going maintenance of the proposed outdoor learning space; and

WHEREAS, District Staff has concluded that this proposed Facilities SEP amendment will facilitate Los Angeles Unified’s ability to successfully complete the Facilities SEP.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The School Construction Citizens’ Bond Oversight Committee recommends the Board of Education define and approve three SEEDS projects at Manchester Avenue Elementary School, Sheridan Street Elementary School, and Park Avenue Elementary School, with a total combined budget of \$350,000, and amend the Facilities SEP to incorporate therein, as defined in Board Report 011-22/23, a copy of which is attached hereto in the form it was presented to the BOC and is incorporated herein by reference.

Facilities Services Division

Action Proposed:

Define and approve three Sustainable Environment Enhancement Developments for Schools (SEEDS) projects at Manchester Avenue Elementary School, Sheridan Street Elementary School, and Park Avenue Elementary School, as described on Attachment A. The total combined budget for the three projects is \$350,000.

Background:

The SEEDS Program supports the development of projects that will enhance school sites by creating outdoor learning spaces in collaboration with school-based and community-led efforts. There are two components to the Program:

1. Development of the outdoor learning space constructed by Los Angeles Unified which includes capital investments, such as asphalt removal, installation of irrigation and utilities, and any associated testing and inspection.
2. Collaboration with a school site and/or partner organization that will outfit the outdoor learning space with the plant materials and landscaping features that align with the school's instructional vision and program. This component is essential to the success of each project.

Potential projects are identified through proposals submitted by schools, and or partners. A school site by itself, or in cooperation with a partner organization, may submit a SEEDS application to receive up to \$100,000 to create or improve an outdoor learning space. An additional \$50,000 ("SEEDS+" funding) is now available to schools ranked in the top 150 on the Los Angeles Unified Greening Index of schools in need of green space.

District staff evaluates the proposals based on the specific criteria and requirements outlined in the SEEDS Program Guide to ensure each proposal meets the eligibility requirements. Proposals must include a written project narrative describing the project scope, an explanation of how the project will be integrated into the school's curriculum, and confirmation of the availability of resources to outfit and maintain the outdoor learning space. The recommended projects included in this Board Report have been reviewed and have been found to comply with the program requirements, including feasibility and equitable distribution throughout the District.

Sheridan Street Elementary School and Park Avenue Elementary School will receive \$100,000 for their SEEDS projects, and Manchester Avenue Elementary School qualifies for an additional \$50,000 in "SEEDS+" funding to receive \$150,000 for its project.

Expected Outcomes:

Approval of this proposed action will enable staff to proceed with the design and construction of these three projects. Approval of these greening projects will improve the learning environment for students, teachers, and staff, increase sustainability, and enhance the outdoor school environment.

Board Options and Consequences:

Approval of this proposed action will authorize staff to proceed with the expenditure of Bond Program funds to execute these projects that support educational programs related to nutrition, health, literacy, math, and science. If these projects are not approved, the school sites will not benefit from the creation of these outdoor learning spaces.

Policy Implications:

The proposed action is consistent with the District's long-term goal to address unmet school facilities needs and provide students with safe and healthy learning environments. The action is also aligned with Board Resolutions that reiterate Los Angeles Unified's commitment to creating green learning spaces (*Expand Sustainable Schoolyards and Environmental Initiatives and Curriculum* Board Resolution adopted on April 16, 2013 and *Creating New School Gardens and Campus and Community-Shared Green Spaces to Provide Outdoor Learning Opportunities and Create Sustainable and Healthy Environments* adopted on February 9, 2021).

Budget Impact:

The combined project budget for the three proposed projects is \$350,000. The projects will be funded with Bond Program funds earmarked specifically for school upgrades and reconfigurations to support wellness, health, athletics, learning, and efficiency.

Student Impact:

The proposed SEEDS projects at Manchester Avenue Elementary School, Sheridan Street Elementary School, and Park Avenue Elementary School will provide outdoor learning spaces that create environments for student-centered, experiential, and engaged learning. These SEEDS learning gardens will facilitate educational programs related to nutrition, health, literacy, math and science and may also be used during recess and lunch-time by the students. These projects also encourage and support community, student and parent engagement through the creation of partnerships that help establish and maintain the newly developed garden spaces.

Issues and Analysis:

In order to ensure the long-term permanence of each SEEDS project, the school site and/or its partner organization must enter into a Maintenance Agreement that provides for the on-going maintenance of the proposed outdoor learning space.

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizen's Oversight Committee (BOC) at its meeting on August 11, 2022. Staff has concluded that this proposed Facilities SEP amendment is in alignment with BOC recommendations and will facilitate Los Angeles Unified's ability to successfully implement the Facilities SEP.

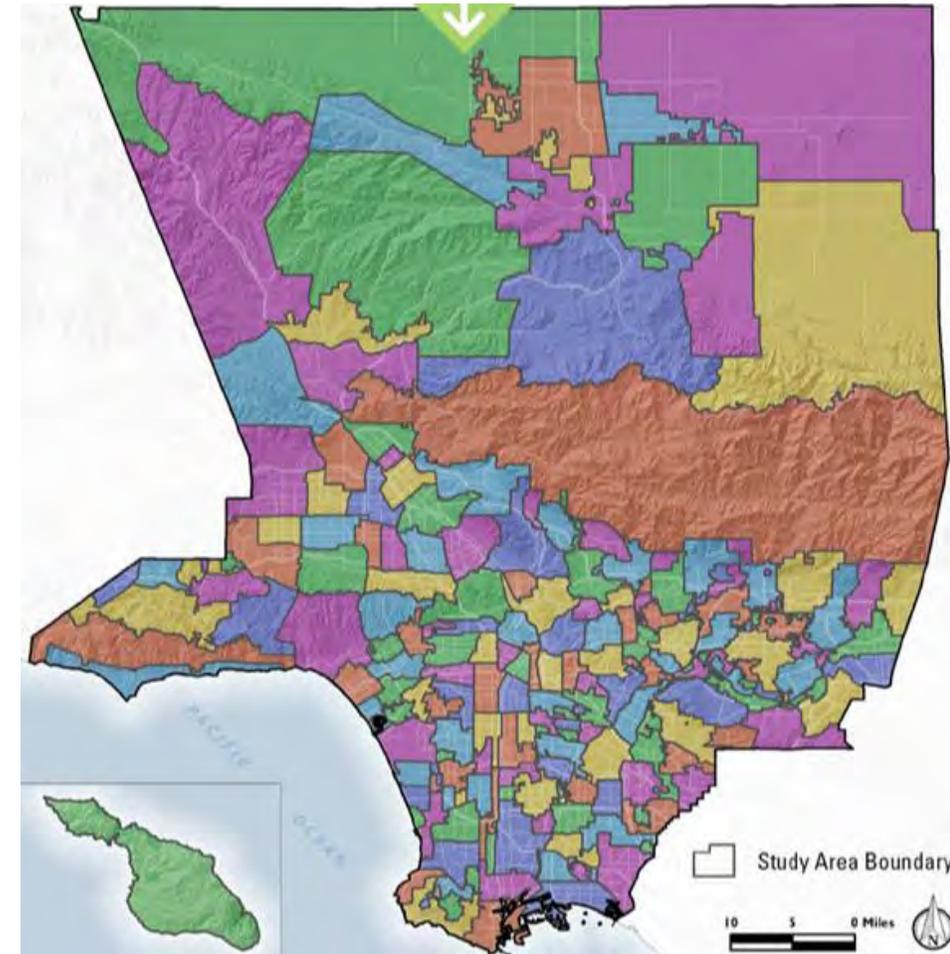

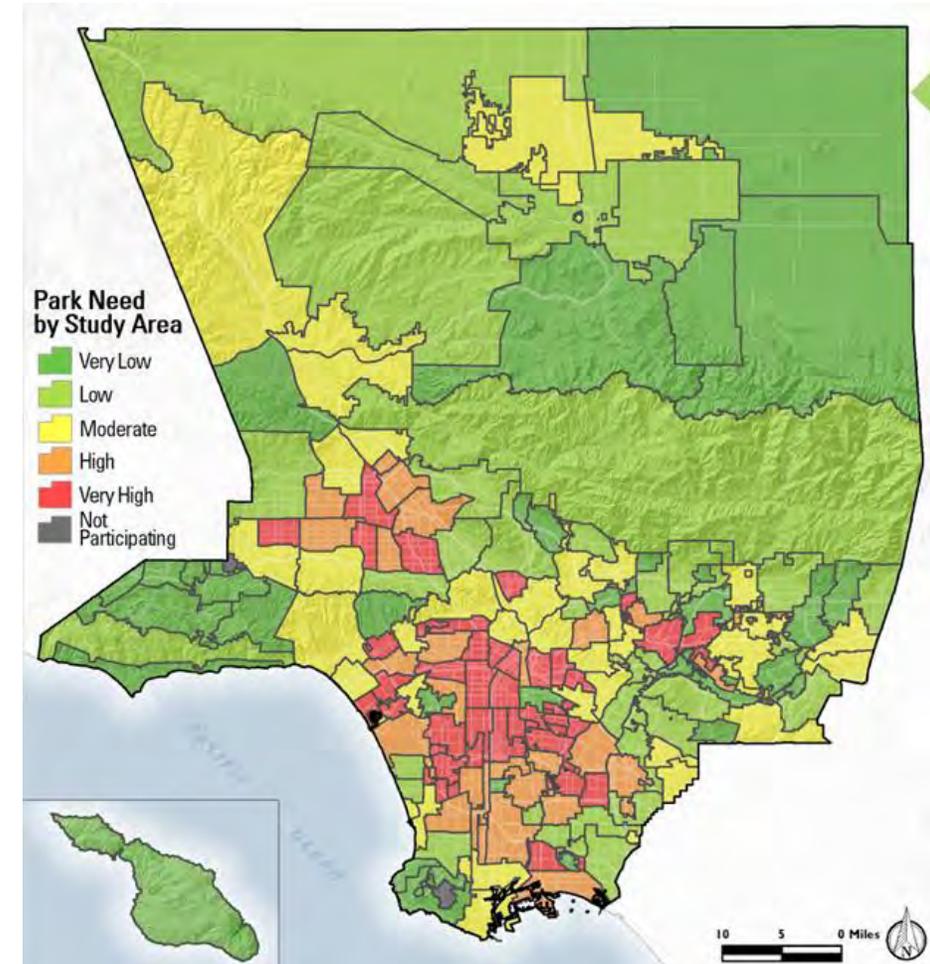

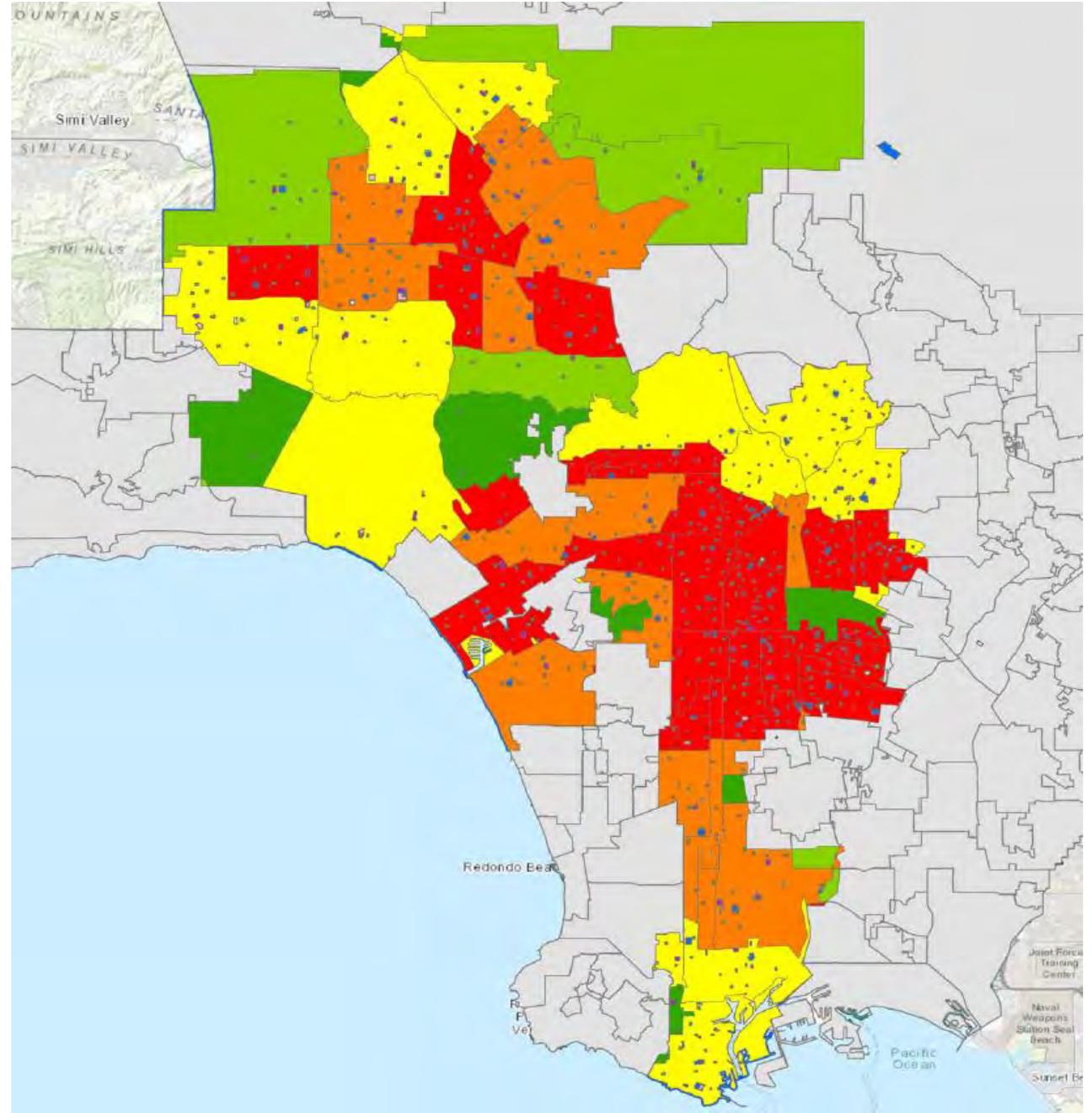

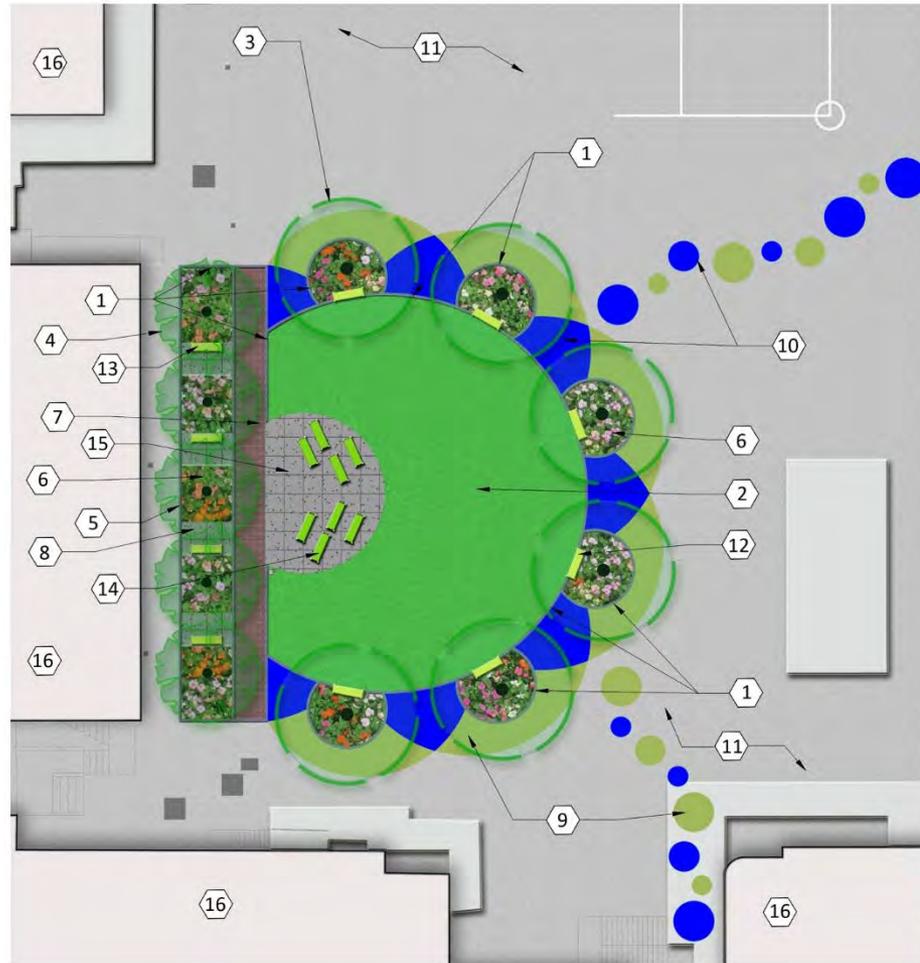

matriculation options, feeder pattern, geographic location, known (or anticipated/matriculating) population of students with disabilities or parents/guardians with disabilities, type of instructional model, and public input. The assigned category reflects the level of accessibility the site needs to meet. Schools that do not yet meet the criteria for their assigned category will undergo accessibility improvements and are prioritized for project development based on the criteria mentioned above. The three categories of accessibility are as follows:

- Category One: These are “key” schools and will have the highest level of access, generally in accordance with applicable physical accessibility standards. Category 1A will provide “full accessibility” for the schools that were built to new construction standards, while Category 1B will provide “high accessibility” for schools that have been altered with some limited exceptions; and
- Category Two: These will be “program-accessible” schools. The core spaces and features of these schools would be made accessible; in addition, program accessibility would be provided to all programs and activities at the school; and
- Category Three: These schools will have “core access,” which means that the core spaces (certain common spaces) would be made accessible, to ensure a basic level of access to the building. These include, for example, parking, the main entrance and main office, assembly areas, and some restrooms; and

WHEREAS, The six school sites for which an accessibility enhancement project is being proposed do not yet meet their assigned category/level of accessibility and thus require facilities improvements. The scope, schedule, and budget for each proposed project reflects the existing known conditions at each school site and the improvements necessary to meet each schools’ assigned category of accessibility. The conditions of significance include acreage, topography, building square footage, existence of multi-story buildings, age of buildings, as well as the number of schools, programs, features and activities at a school site; and

WHEREAS, A need to accommodate students and staff with disabilities to access the main entrance, multipurpose room, and restroom facilities at Curtiss MS has been identified. Facilities staff was previously delegated authority to execute and expend Bond Program funds for Rapid Access Program (RAP) projects in response to an individual student’s need for programmatic access. These projects require minor installments and adjustments to facilities to ensure a barrier-free learning environment, do not require Division of the State Architect (DSA) approval and thus can be completed “rapidly” and have a project budget that does not exceed \$250,000. The proposed ADA barrier removal project at Curtiss MS does not meet the parameters of the RAP due to its scope and budget. As such, staff is presenting the project proposal to the Board for approval; and

WHEREAS, The total combined budget, as currently estimated, for the seven proposed projects is \$47,811,123 and will be funded with Bond Program funds earmarked specifically for ADA Transition Plan Implementation; and

WHEREAS, Construction of the six accessibility enhancement projects are anticipated to begin in the third quarter of 2024 and be completed in the first quarter of 2026. Construction of the Curtiss MS ADA barrier removal project is anticipated to begin in the first quarter of 2024 and be completed in the fourth quarter of 2024; and

Define and Approve Six Accessibility Enhancement Projects, One Barrier Removal Project, and Amend the Facilities Services Division Strategic Execution Plan to Incorporate Therein

Facilities Services Division and Division of Special Education

Action Proposed:

Define and approve six accessibility enhancement projects, at the schools listed below, as described in Exhibit A, to support the implementation of the Board of Education (Board)-approved Self-Evaluation and Transition Plan under the Americans with Disabilities Act (ADA) and one ADA barrier removal project at Glenn Hammond Curtiss Middle School (Curtiss MS), and amend the Facilities Services Division (Facilities) Strategic Execution Plan (SEP) to incorporate therein:

1. 7th Street Elementary Arts Integration Magnet (7th St EAIM)
2. Arminta Street Elementary School (Arminta ES)
3. Atwater Avenue Elementary School (Atwater ES)
4. Chatsworth Park Elementary Urban Planning California Distinguished Magnet (Chatsworth Park EUPCDM)
5. Christopher Columbus Middle School (Columbus MS)
6. Florence Nightingale Middle School (Nightingale MS)

The total combined budget for the seven proposed projects is \$47,811,123

Authorize the Chief Procurement Officer and/or the Chief Facilities Executive and/or their designee(s) to execute all instruments necessary, as legally permissible, to implement the projects including budget modifications and the purchase of equipment and materials.

Background:

On October 10, 2017, the Board approved the Self-Evaluation and Transition Plan (Transition Plan) under the Americans with Disabilities Act (ADA) to further Los Angeles Unified efforts to comply with ADA Title II program accessibility requirements (Board Report No. 124-17/18). The Transition Plan outlined Los Angeles Unified's proposed approach to providing program accessibility, which considers the characteristics of Los Angeles Unified, student population, variety of educational programs, as well as the existing level of accessibility. The Transition Plan established a specific approach and goals for achieving program accessibility within eight years through facility modifications and operational means.

Under the Transition Plan, each school is assigned to one of three levels of accessibility (Category One, Two, or Three) based on assessments of more than two dozen criteria, including school programs, matriculation options, feeder pattern, geographic location, known (or anticipated/matriculating) population of students with disabilities or parents/guardians with disabilities, type of instructional model, and public input. The assigned category reflects the level of accessibility the site needs to meet. Schools that do not yet meet the criteria for their assigned category will undergo accessibility improvements and are prioritized for project development based on the criteria mentioned above. The three categories of accessibility are as follows:

- Category One: These are “key” schools and will have the highest level of access, generally in accordance with applicable physical accessibility standards. Category 1A will provide “full accessibility” for the schools that were built to new construction standards, while Category 1B will provide “high accessibility” for schools that have been altered with some limited exceptions.
- Category Two: These will be “program-accessible” schools. The core spaces and features of these schools would be made accessible; in addition, program accessibility would be provided to all programs and activities at the school.
- Category Three: These schools will have “core access,” which means that the core spaces (certain common spaces) would be made accessible, to ensure a basic level of access to the building. These include, for example, parking, the main entrance and main office, assembly areas, and some restrooms.

The six school sites for which an accessibility enhancement project is being proposed do not yet meet their assigned category/level of accessibility and thus require facilities improvements. The scope, schedule, and budget for each proposed project reflects the existing known conditions at each school site and the improvements necessary to meet each schools’ assigned category of accessibility. The conditions of significance include acreage, topography, building square footage, existence of multi-story buildings, age of buildings, as well as the number of schools, programs, features and activities at a school site.

A need to accommodate students and staff with disabilities to access the main entrance, multipurpose room, and restroom facilities at Curtiss MS has been identified. Facilities staff was previously delegated authority to execute and expend Bond Program funds for Rapid Access Program (RAP) projects in response to an individual student’s need for programmatic access. These projects require minor installments and adjustments to facilities to ensure a barrier-free learning environment, do not require Division of the State Architect (DSA) approval and thus can be completed “rapidly” and have a project budget that does not exceed \$250,000. The proposed ADA barrier removal project at Curtiss MS does not meet the parameters of the RAP due to its scope and budget. As such, staff is presenting the project proposal to the Board for approval.

Expected Outcomes:

Define and approve six accessibility enhancement projects and one ADA barrier removal project, as detailed in Exhibit A, and adopt the proposed amendment to the Facilities SEP to incorporate therein. Approval will authorize staff to proceed with the implementation of the proposed projects.

Board Options and Consequences:

Adoption of the proposed action will authorize staff to proceed with the expenditure of Bond Program funds to immediately begin designing the proposed projects at seven school sites.

If the Board does not approve the proposal, staff will be unable to initiate the six proposed accessibility enhancement projects, which are necessary to achieve program accessibility as outlined in the Transition Plan, and the ADA barrier removal project at Curtiss MS, which is required for compliance with Section 504 of the Rehabilitation Act and the ADA.

Policy Implications:

The proposal furthers implementation of the Transition Plan. As outlined in the Transition Plan, at Category One, Two and Three schools, an appropriate number of classrooms will be identified to serve as accessible

learning spaces, some of which may require facility improvements to meet the criteria for their assigned accessibility category.

Any potential future room changes by Administrators or Principals will be reviewed by the Division of Special Education, the ADA Compliance Administrator, and the Facilities Services Division to ensure that new accessibility problems are not created as a result of the classroom moves. This will be done in close coordination with school staff to ensure disruptions are minimized.

Budget Impact:

The total combined budget, as currently estimated, for the seven proposed projects is \$47,811,123. The projects will be funded with Bond Program funds earmarked specifically for ADA Transition Plan Implementation.

Each project budget was prepared based on the current information known, and assumptions about the project scope, site conditions, and market conditions. Individual project budgets will be reviewed throughout the planning, design, and construction phases as new information becomes known or unforeseen conditions arise and will be adjusted accordingly to enable the successful completion of each project.

Student Impact:

The seven proposed projects will remove barriers to program accessibility for students and qualified members of the community and ensure that all have an equal opportunity to access programs and activities at each campus.

Issues and Analysis:

Both Title II of the ADA and Section 504 of the Rehabilitation Act of 1973 impose broad-reaching prohibitions against discrimination on the basis of disability. As to facilities, a key requirement for both the ADA and Section 504 is program accessibility: programs, benefits, services, and activities provided by public entities must be accessible to people with disabilities. This means that a qualified individual with a disability is not to be discriminated against because the entity's facilities are inaccessible; however, this does not necessarily mean that all facilities must be accessible. While both laws do require that newly constructed and altered facilities meet stringent accessibility requirements, they do not require that all existing facilities meet those standards, so long as the programs and services provided in those facilities are made accessible to people with disabilities. A program or service can be made accessible by relocating it, providing it in a different manner, or utilizing some other strategy to ensure that people with disabilities have an equal opportunity to benefit from the entity's programs and activities. These proposed projects are in alignment with Los Angeles Unified's implementation of the Board-approved Self-Evaluation and Transition Plan.

Curtiss MS has been assigned a Category Two accessibility level pursuant to the Transition Plan. Staff considered the possibility of reprioritizing the school on the Transition Plan list and proposing a more robust scope that would address all programmatic access requirements. However, it was determined that constructing two concrete ramps to provide students and staff with direct access to the entrance of the school, multipurpose room, and upgrading two restroom facilities was an immediate and pressing priority, and additional accessibility improvements could be undertaken under a new project and at a later date, as anticipated under the Transition Plan.

The Office of Environmental Health and Safety (OEHS) will evaluate the proposed projects in accordance with the California Environmental Quality Act (CEQA).

Bond Oversight Committee Recommendations:

This item was considered by the School Construction Bond Citizens' Oversight Committee (BOC) at its meeting on August 11, 2022. Staff has concluded that this proposed Facilities SEP amendment is in alignment with BOC recommendations and will facilitate Los Angeles Unified's ability to successfully complete the Facilities SEP.

1. 7th Street Elementary Arts Integration Magnet Accessibility Enhancement Project

San Pedro Community of Schools, Local District South, Board District 7 (Tanya Ortiz Franklin)

Project Background and Scope: The 7th Street Elementary Arts Integration Magnet site spans 6.06 acres and is comprised of a K-5 magnet school program. The building area is approximately 48,543 square feet and includes two multi-story permanent buildings, one single-story permanent building, and eight relocatable buildings. The permanent buildings were constructed between 1963 and 1976. As of the 2021-2022 Electronic Capacity Assessment Review (E-CAR), the school served 271 students and currently 55 have been identified as having a disability.

The site has been assigned a Category Two accessibility level. In order to meet the criteria for Category Two, various upgrades to six buildings are required, including: corrections, installation or replacement of one elevator with covered bridge, one new wheelchair lift, one concrete ramp, nine restroom upgrades, one sink/cabinet, one stage adapt, 13 path of travel upgrades, two railings/wing guards, two drinking fountain upgrades, three assembly seat upgrades, one assistive listening device, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$9,065,859

Project Schedule: Construction is anticipated to begin in Q3-2024 and be completed in Q1-2026.

2. Arminta Street Elementary School Accessibility Enhancement Project

Sun Valley Community of Schools, Local District Northeast, Board District 6 (Kelly Gonez)

Project Background and Scope: The Arminta Street Elementary School site spans 5.17 acres and is comprised of a traditional K-5 elementary school program. The building area is approximately 38,987 square feet and includes seven single-story permanent buildings, one multi-story permanent building and 11 relocatable buildings. The permanent buildings were constructed in 1953. As of the 2021-2022 E-CAR, the school served 346 students and currently 59 have been identified as having a disability.

The site has been assigned a Category Two accessibility level. In order to meet the criteria for Category Two, various upgrades to 16 buildings are required, including: corrections, installation or replacement of three assembly seat upgrades, one assistive listening device, one cafeteria counter, one concrete ramp, 11 TMP ramps, six drinking fountain upgrades, 19 accessible path of travel upgrades, 12 railings/wing guards, 10 restroom upgrades, one stage adapt, one new wheelchair lift, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$7,947,569

Project Schedule: Construction is anticipated to begin in Q3-2024 and be completed in Q1-2026.

3. Atwater Avenue Elementary School Accessibility Enhancement Project

Glassell Park / Los Feliz Community of Schools, Local District Central, Board District 5 (Jackie Goldberg)

Project Background and Scope: The Atwater Avenue Elementary School site spans 3.92 acres and is comprised of two K-6 schools/programs, a traditional elementary school program and a dual language two-way immersion Spanish program. The building area is approximately 41,729 square feet and includes two single-story permanent buildings, one multi-story permanent building and nine relocatable buildings. The permanent buildings were constructed between 1960 and 1975. As of the 2021-2022 E-CAR, the school served 283 students and currently 67 have been identified as having a disability.

The site has been assigned a Category Three accessibility level. In order to meet the criteria for Category Three, various upgrades to seven buildings are required, including: corrections, installation or replacement of one assistive listening device, one automatic door opener, one cafeteria counter, one concrete ramp, five drinking fountain upgrades, one existing elevator upgrade, two parking lot upgrades, 20 accessible path of travel upgrades, nine railings/wing guards, eight restroom upgrades, one sink/cabinet, one stage adapt, one new wheelchair lift, one TMP ramp, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$5,010,938

Project Schedule: Construction is anticipated to begin in Q3-2024 and be completed in Q1-2026.

4. Chatsworth Park Elementary Urban Planning/California Distinguished Magnet Accessibility Enhancement Project

Canoga Park / Chatsworth Community of Schools, Local District Northwest, Board District 3 (Scott Schmerelson)

Project Background and Scope: The Chatsworth Park Elementary Urban Planning/California Distinguished Magnet site spans 5.76 acres and is comprised of a K-5 magnet school program. The building area is approximately 32,650 square feet and includes four single-story permanent buildings, one multi-story permanent building and seven relocatable buildings. The permanent buildings were constructed between 1935 and 1959, with some identified as historical resources. As of the 2021-2022 E-CAR, the school served 375 students and currently 34 have been identified as having a disability.

The site has been assigned a Category Two accessibility level. In order to meet the criteria for Category Two, various upgrades to five buildings are required, including: corrections, installation, or replacement of three assembly seat upgrades, two assistive listening devices, three concrete ramps, two drinking fountain upgrades, one playground component/matting, five accessible path of travel upgrades, seven railings/wing guards, seven restroom upgrades, two sinks/cabinets, one stage adapt, one new wheelchair lift, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$5,622,671

Project Schedule: Construction is anticipated to begin in Q3-2024 and be completed in Q1-2026

5. Christopher Columbus Middle School Accessibility Enhancement Project

Canoga Park / Chatsworth Community of Schools, Local District Northwest, Board District 3 (Scott Schmerelson)

Project Background and Scope: The Christopher Columbus Middle School site spans 19.96 acres and is comprised of four 6-8 schools/programs, a traditional middle school program, a medical/math/science magnet program, a media arts/communication magnet program, and a co-located charter school program. The building area is approximately 131,128 square feet and includes 18 single-story permanent buildings, four multi-story permanent buildings, and two relocatable buildings. The permanent buildings were constructed between 1959 and 1965. As of the 2021-2022 E-CAR, the school served 649 students and currently 114 have been identified as having a disability.

The site has been assigned a Category Two accessibility level. In order to meet the criteria for Category Two, various upgrades to 21 buildings are required, including: corrections, installation, or replacement of five assistive listening devices, one automatic door opener, one cafeteria counter, six concrete ramps, 15 drinking fountain upgrades, two locker upgrades, one parking lot upgrade, 78 accessible path of travel upgrades, 13 railings/wing guards, 19 restroom upgrades, two sinks/cabinets, one stage adapt, one new wheelchair lift, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$12,002,244

Project Schedule: Construction is anticipated to begin in Q3-2024 and be completed in Q1-2026.

6. Florence Nightingale Middle School Accessibility Enhancement Project

Lincoln Heights / El Sereno Community of Schools, Local District East, Board District 2 (Mónica García)

Project Background and Scope: The Florence Nightingale Middle School site spans 8.85 acres and is comprised of four 6-8 schools/programs, one traditional middle school program, a medicine/health/kinesiology magnet program, a business entrepreneurship technology magnet program, and a gifted stem magnet program. The building area is approximately 154,568 square feet and includes three single-story permanent buildings, and nine multi-story buildings. The permanent buildings were constructed between 1937 and 1971, with some identified as historical resources. As of the 2021-2022 E-CAR, the school served 809 students and currently 146 have been identified as having a disability.

The site has been assigned a Category Three accessibility level. In order to meet the criteria for Category Three, various upgrades to nine buildings are required, including: corrections, installation, or replacement of three assembly seat upgrades, one assistive listening device, four automatic door openers, two concrete ramps, three drinking fountain upgrades, 12 accessible path of travel upgrades, four railings/wing guards, seven restroom upgrades, one stage adapt, one new wheelchair lift, other miscellaneous upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$5,651,586

Project Schedule: Construction is anticipated to begin in Q3-2024 and be complete in Q1-2026.

7. Glenn Hammond Curtiss Middle School Barrier Removal Project

Carson Community of Schools, Local District South, Board District 7 (Tanya Ortiz Franklin)

Project Background and Scope: The Glenn Hammond Curtiss Middle School site spans 19.88 acres and is comprised of three 6-8 schools/programs, a traditional middle school program, a science/technology/engineering/art/mathematics magnet program, and a co-located charter school program. The building area is approximately 159,950 square feet and includes three single-story permanent buildings, four multi-story buildings, and five relocatable buildings. The permanent buildings were constructed in 1969. As of the 2021-2022 E-CAR, the school served 359 students and currently 59 have been identified as having a disability.

This is an Americans with Disabilities Act barrier removal project to accommodate students and staff with disabilities to access the main entrance, multipurpose room, and restroom facilities at the school. The project will include the construction of two concrete ramps, two restroom upgrades, and any other required improvements or mitigations to ensure compliance with local, state and/or federal facilities requirements.

Project Budget: \$2,510,256

Project Schedule: Construction is anticipated to begin in Q1-2024 and be completed in Q4-2024.

Venice High School Auditorium Renovation

Venice High School Auditorium Renovation

Project Status: 60% Construction Complete

- **Scope:** The crown molding attached to the walls and ceiling of the auditorium has deteriorated and become a safety hazard. Seismic upgrade to the ceiling is required. This project includes the repair, replacement, and preservation of crown molding elements; creation of an expansion joint between the ceiling plane and crown molding; installation of a modern anchorage system to anchor both old and new crown molding sections to the walls; repainting of the auditorium ceiling; new fabric-wrapped acoustical ceiling tiles; and adding new fabric-wrapped acoustical panels on the rear wall. The seismic upgrade to the ceiling will include new re-attachment details for the entire perimeter, and installation of a new grid of compression struts with diagonal splay wires & new connections. The repairs will be performed as recommended by a Historical Restoration Architect to preserve the historically significant features of the auditorium. This job includes significant abatement of hot plaster at walls and ceilings.

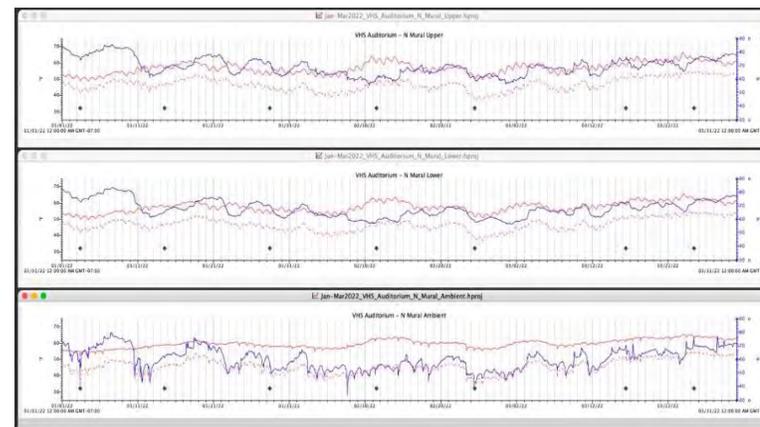

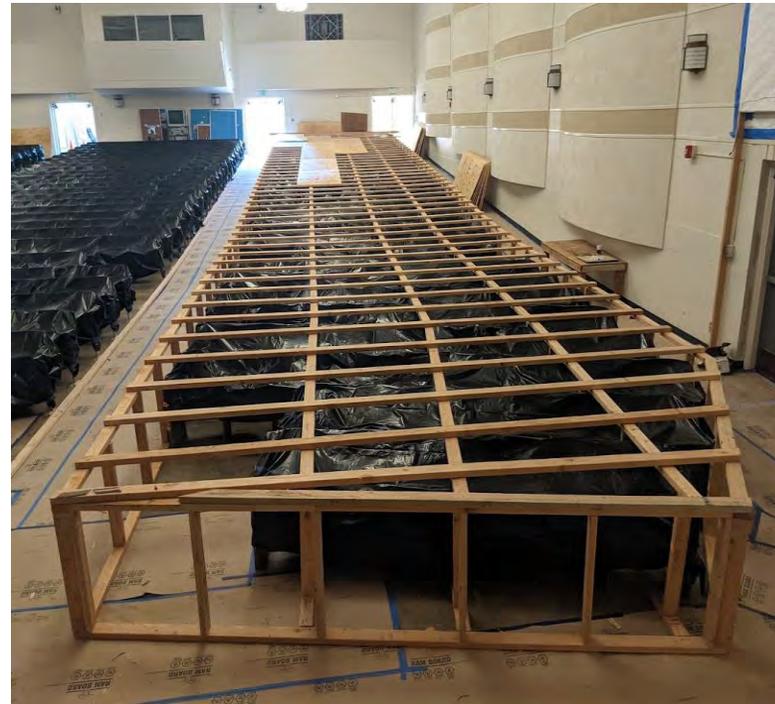

SEATING PROTECTION

- Existing seats are bolted to the concrete floor with expansion bolts, anchors and shot pins. Removal and reinstallation of the seats was originally planned, but it was determined that the best way to protect the seats from damage during construction was to build a protective enclosure around them.
 - Seats were first covered with Visqueen.
 - Engineered wood enclosure constructed in-place around the seats.
 - Fondly referred to by the project team as “Noah’s Ark.”

SCAFFOLD AND LIGHTING PROTECTION

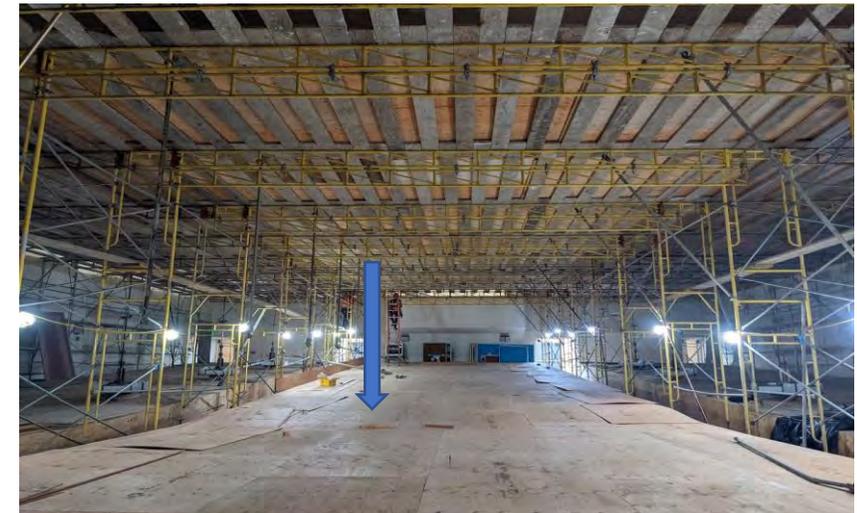
- A full “Dance Floor” engineered scaffold system was installed to create a working platform seven feet under the elevation of the historic ceiling.
- Scaffold was engineered to fit between the rows of seats and completion of seating protection was installed in tandem with the scaffold installation.
- Historic light fixtures were lowered down below the scaffold, boxed out, and secured to the top of the seating structure protect them in place.

REPLACEMENT RESTORATION AND SECURING OF CROWN MOLDINGS

Over time, crown moldings had become unstable. After installation of the Dance Floor scaffold, each piece of molding was assessed for soundness.

- Moldings that were still structurally sound were seismically attached to the building structure above using washers, wires and structural hardware. Washer locations were patched back and renovated to match their historic condition.
- Unsound moldings were replaced with new sections. A mold was created from the original building sections and new plaster casts were poured. New panels were created to fill in the areas where unsound moldings had been removed.
- All moldings are painted to match their historic condition.
- Molding work was performed by a historic renovation specialty subcontractor.

CORBEL REPAIR

Upon closer inspection, cracks were observed, and corbels were determined to be separating from the ceiling.

- Supporting wires were installed to pull the corbels flush the building structure above it.
- Corbels were then historically renovated by a specialty subcontractor.

UNFORESEEN REPAIRS

Removal of ceiling tiles revealed ceiling repair work from earlier projects due to water intrusion. These portions of the ceiling had been patched to a lesser quality than the original construction. Previous poor plaster repair, rusted lath, and damaged plaster were removed and repaired by a quality plaster subcontractor to match the quality of the original construction.

- Areas around HVAC registers had been patched with drywall that did not match the historic plaster ceiling. Drywall was removed and patched with historically accurate plaster.

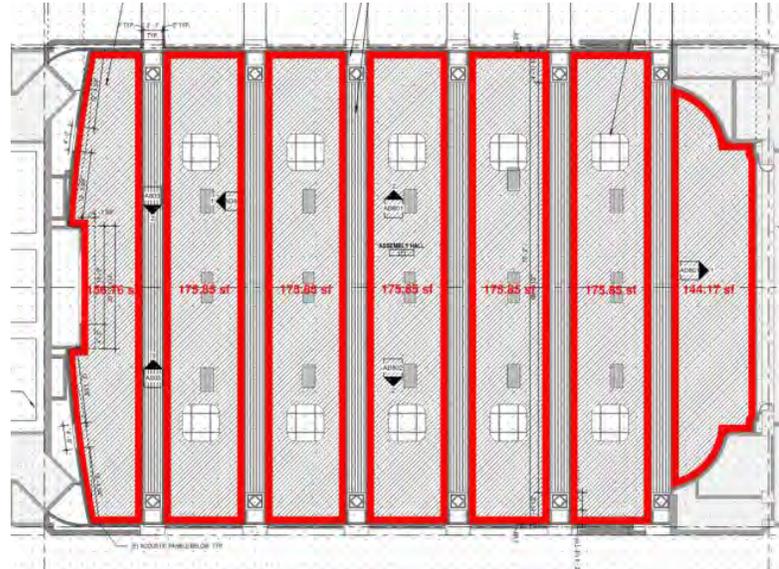

12" BAND DECORATIVE TRIM REPAIR

Cracks were observed throughout the decorative trim at the ceiling (shown in red highlight). Cracks were initially repaired but continued to recur as the seismic ceiling work above it progressed.

To ensure safety, the 12" band is being replaced in its entirety. The new trim is being seismically separated from the walls and attached to the original structure above using high strength plaster.

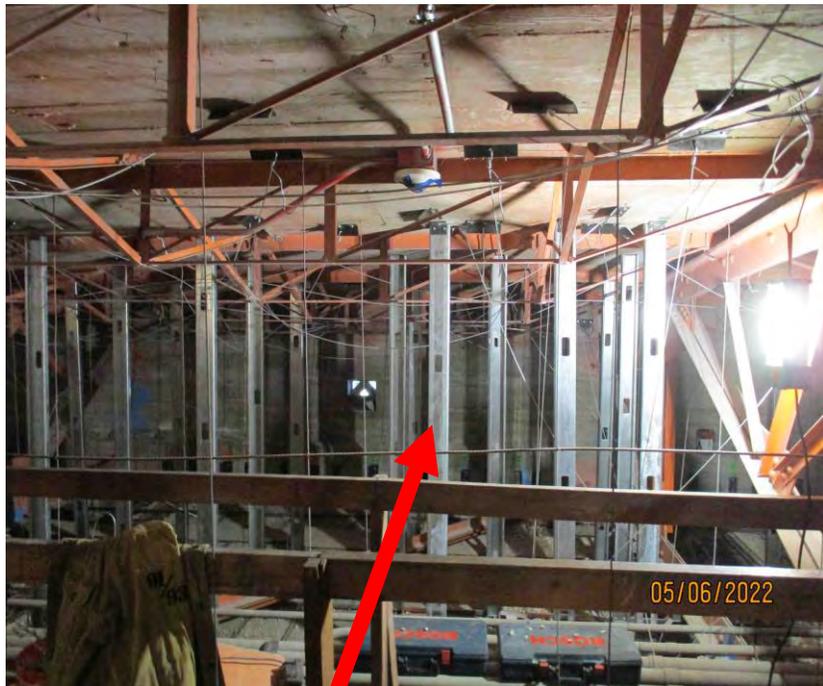

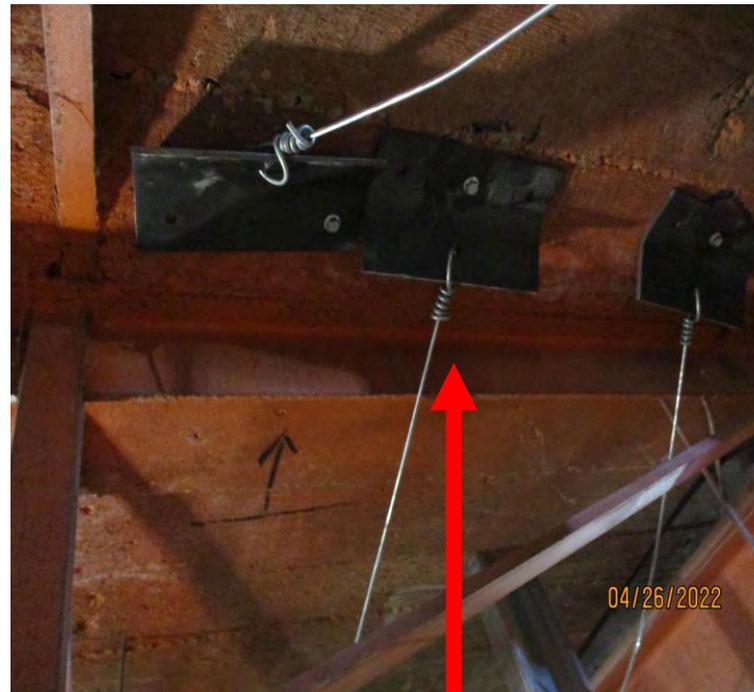
VOLUNTARY SEISMIC UPGRADE OF CEILING

Significant structural upgrades are being installed to better tie original black iron and plaster ceiling to concrete and steel roof structural system above it. Seismic upgrade work is constructed within the restricted space of the attic.

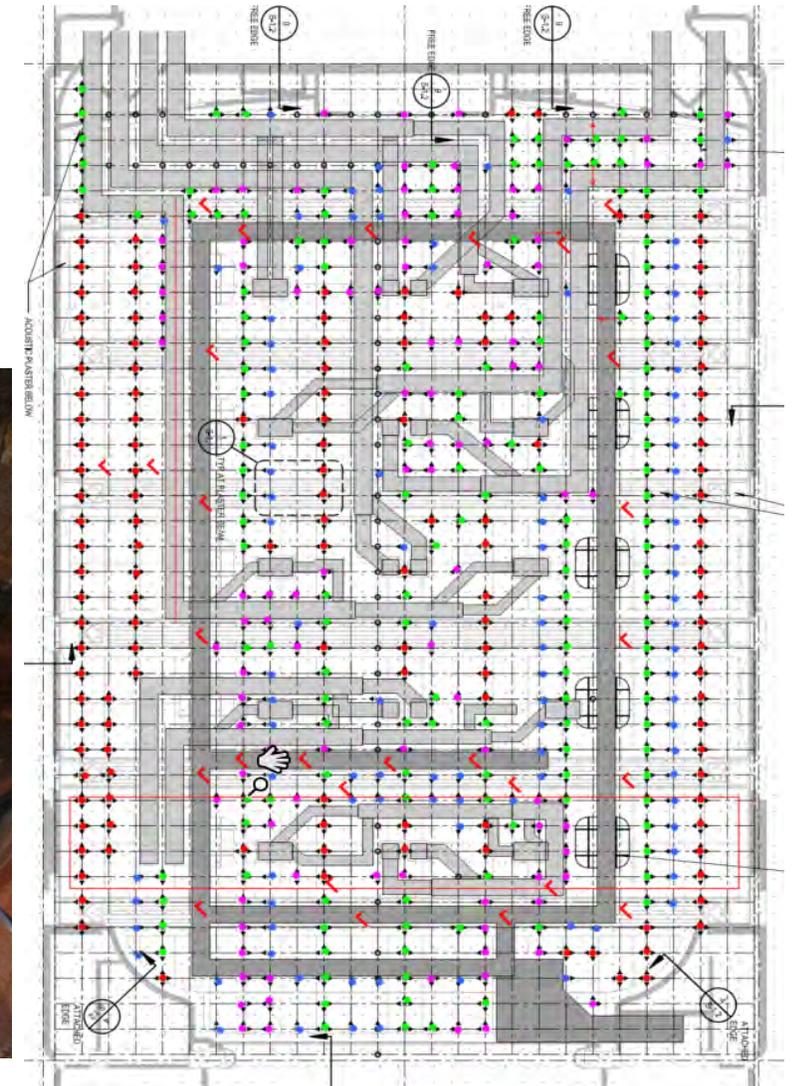
- 486 compression posts installed to stabilize the plaster support system and create a rigid connection to the concrete roof above.
- 1,290 splay wires installed to stabilize the compression posts.

SEISMIC SEPARATION OF CEILING FROM WALLS

The entire historic black iron and plaster ceiling system is further stabilized by strengthening the attachment to the building on the north and east sides while creating a seismic separation between the ceiling system and the concrete walls at the west and south sides.

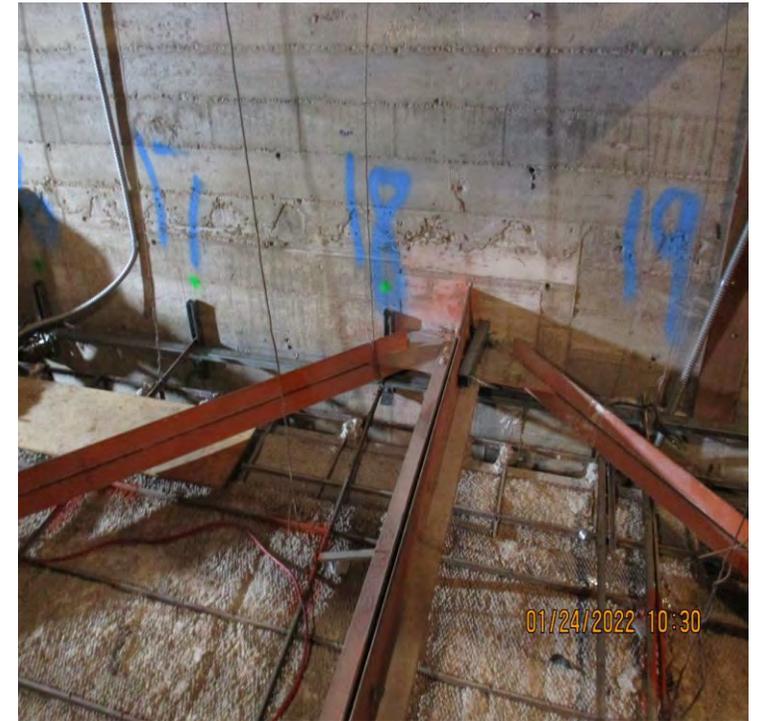
- Framing secured to north and east perimeter walls using angles and concrete anchors.
- Seismic separation created at south and west perimeter walls by cutting the runners away from the concrete and reattaching it from above using angles, unistruts and hangers.

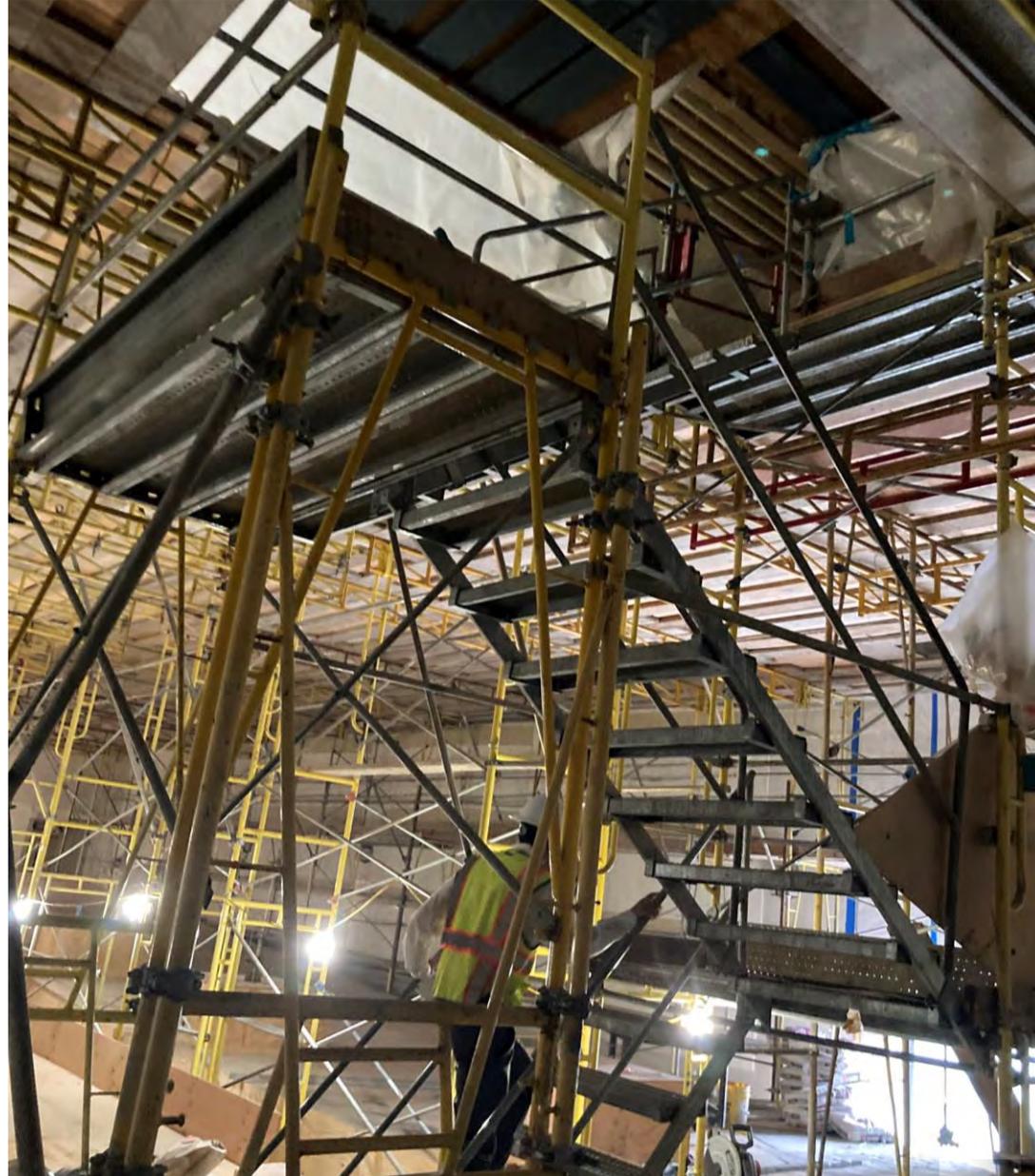

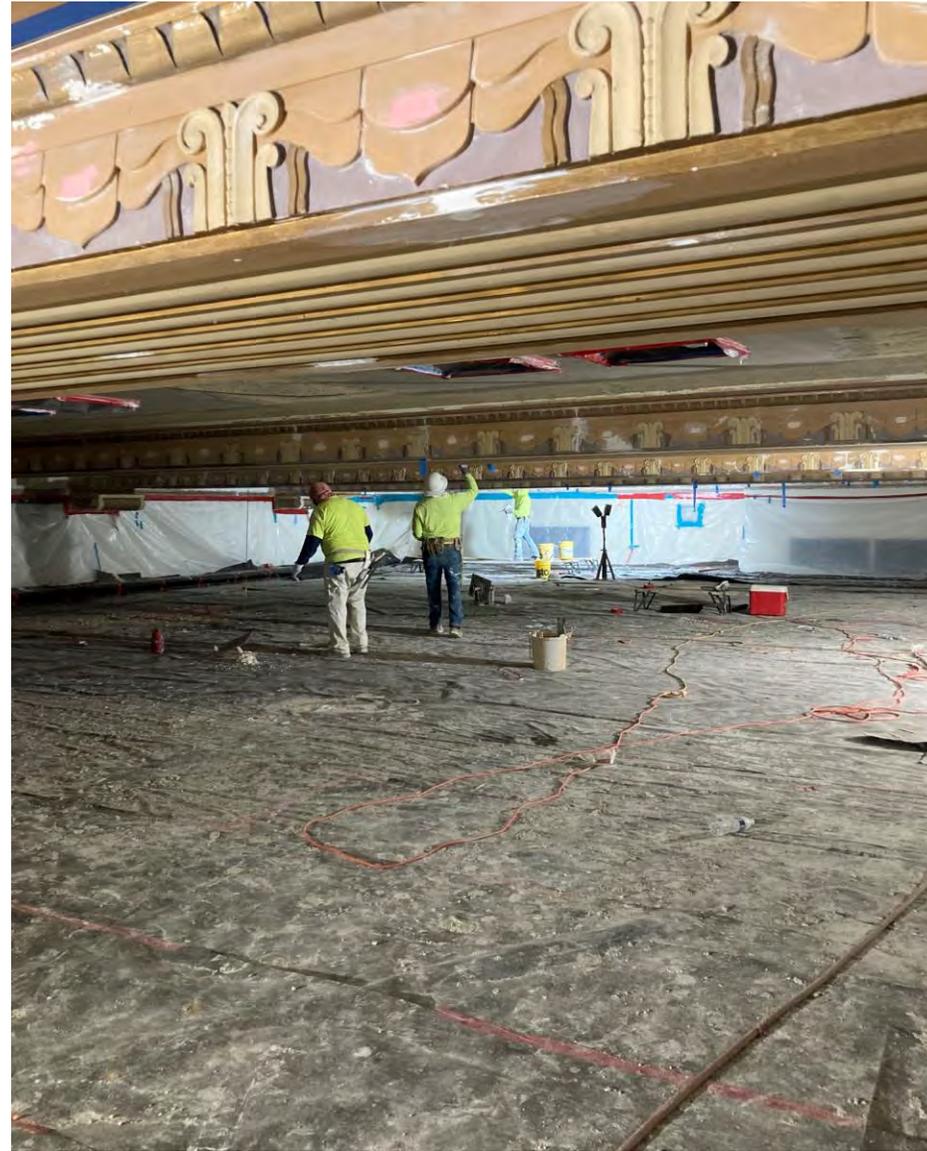

ACCESS

Accessing the work areas is a constant challenge.

- Stairs and ladders provide access to the work progressively up through the scaffold "Dance Floor" where renovation work is taking place, to the attic where the seismic bracing work is done, and to the roof.
- Attic seismic work must be constructed from catwalks
- Low ceilings and ducts at the attic complicate the seismic bracing work.
- Supplies are brought up the ladders through access hatches.

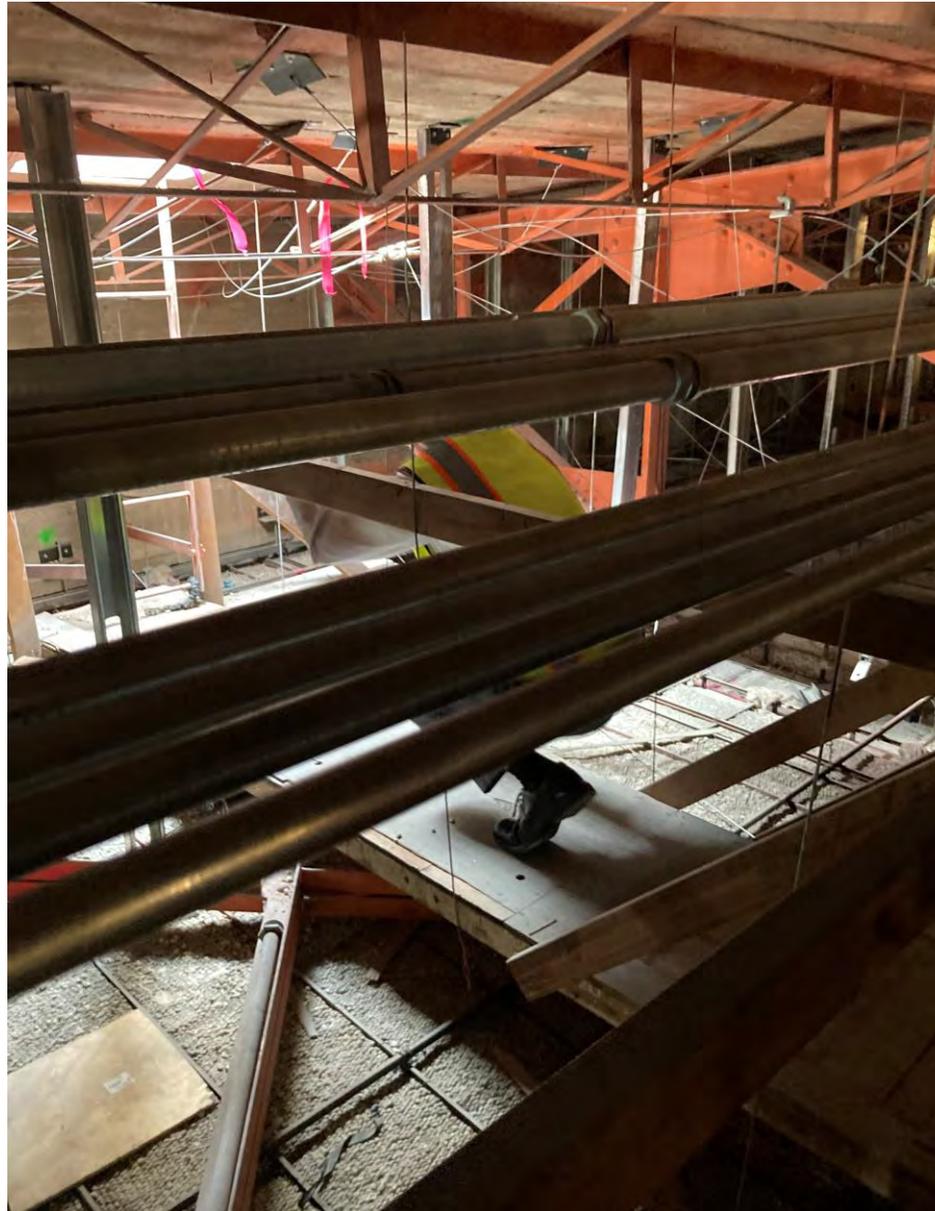

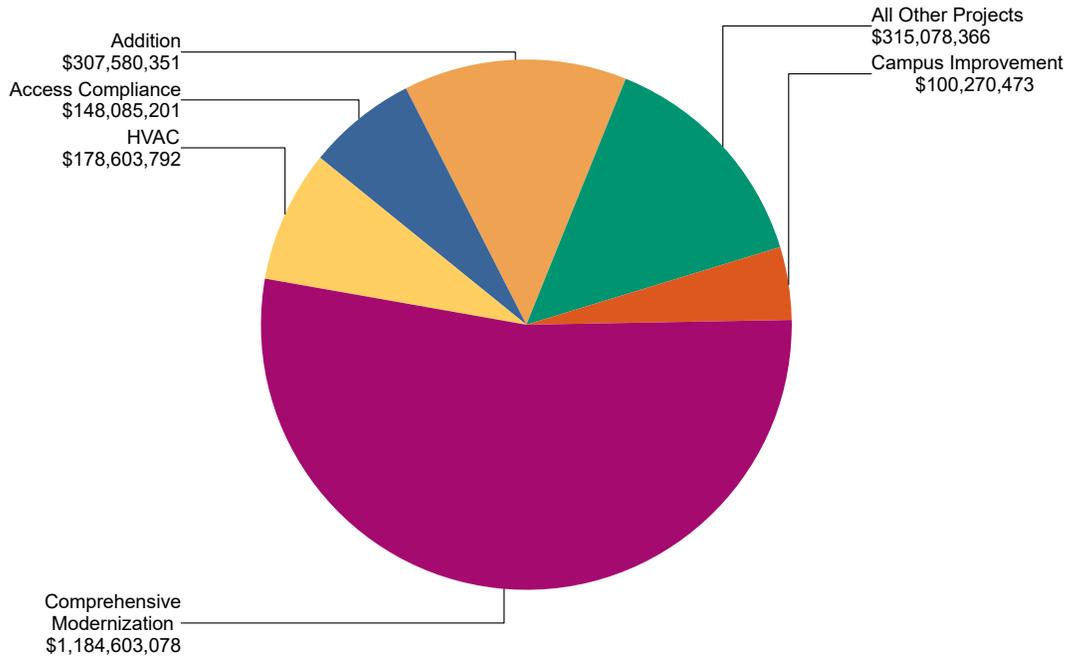

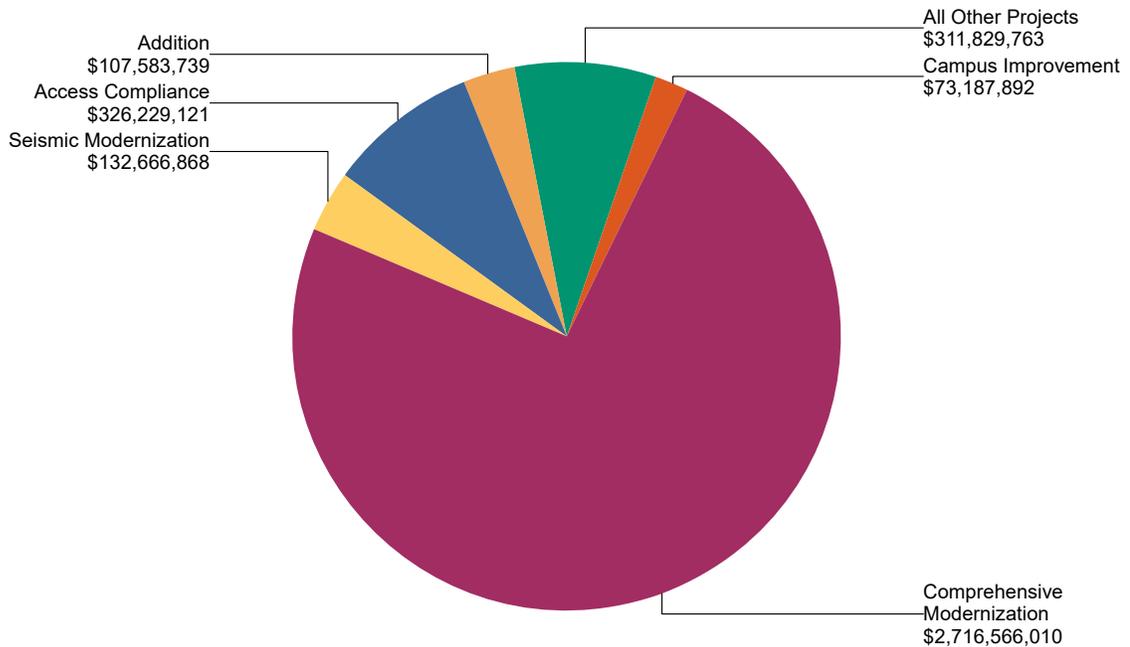


TOTAL BUDGET OF FIVE LARGEST PROJECT TYPES

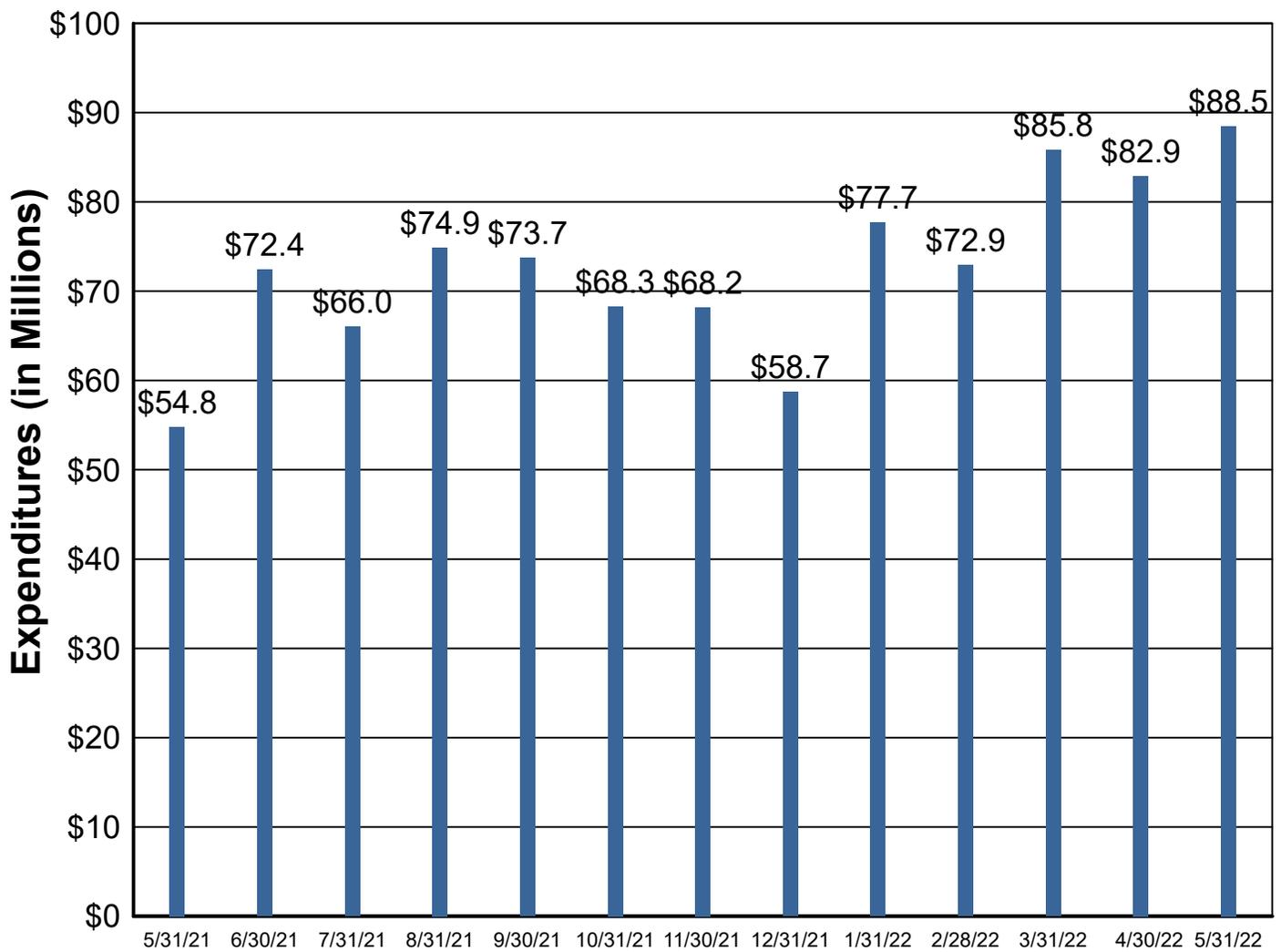

INTRODUCTION

The Information Technology Division (ITD) is responsible for building and maintaining the technology needed to support 21st century teaching and learning in Los Angeles Unified.

Mission

The Information Technology Division's mission is to enable student achievement and operational efficiency through deployment of appropriate technical solutions for our students and their families, our employees, and the community. ITD facilitates these deployments through the following programs:

- Classroom Technology Modernization
- Applications Modernization
- School Network Technology Infrastructure Modernization
- Safety, Communications, and Security Modernization
- Disaster Recovery and Business Continuity

Vision

ITD is customer-focused, proactive, and innovative in providing appropriate and effective technological solutions to facilitate each student's path to college and career readiness.

Guiding Principles

ITD aligns its efforts to the priorities set forth by the Board of Education and Superintendent. Los Angeles Unified, industry, state, and national standards are the foundation of the Division's four guiding principles:

- 1) Improving governance and transparency,
- 2) Improving communication and training to help simplify technology,
- 3) Aligning initiatives within the comprehensive enterprise architecture, and
- 4) Supporting and developing staff.

These guiding principles support the following key goals:

- Optimize the information, applications, and communication infrastructure supporting the high-performance 21st century learning environment
- Increase efficiency and effectiveness thus freeing up resources for the classroom

Bond History

The Information Technology Division has graciously been able to utilize Local Bond Measure proceeds to achieve the District's goals. Below is a brief history of those bonds, their passage and the total funds approved for Los Angeles Unified.

November 2002, Local Measure K

Voters approved Measure K with \$3.35 billion in local funding for the new construction and modernization of K-12 facilities as well as funding for charter school facilities, critically overcrowded schools, and joint use projects.

March 2004, Local Measure R

Voters approved the \$3.87 billion local bond Measure R for new school construction, modernization and repairs.

November 2005, Local Measure Y

Voters approved local bond Measure Y, which provided \$3.985 billion for new school construction, modernization and repair.

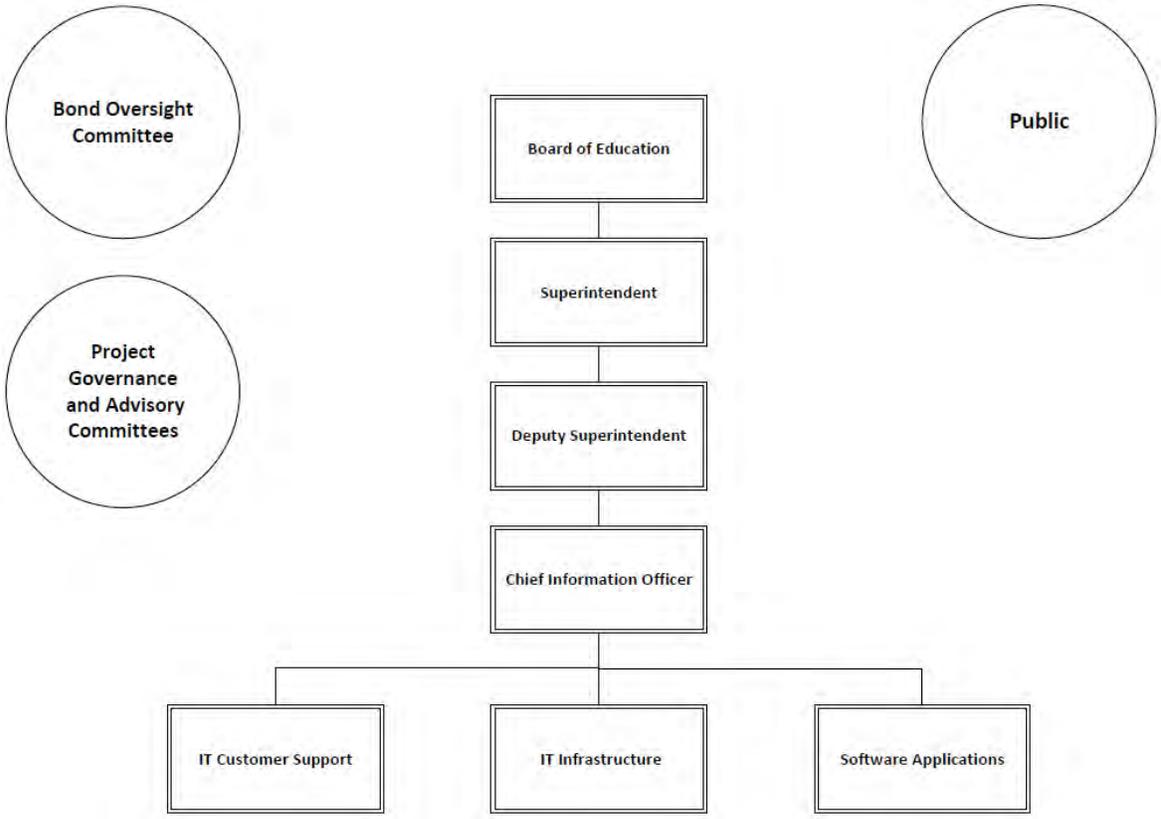
November 2008, Local Measure Q

Voters approved local bond Measure Q, which provided \$7 billion for repairing aging schools, upgrading schools to modern technology, creating additional capacity, promoting a healthier environment, and ensuring transparency and accountability.

November 2020, Local Measure RR

Voters approved local bond Measure RR, providing \$7 billion to upgrade and modernize campuses for 21st century learning and COVID-19 safety standards, address inequities in Los Angeles public school facilities, and improve accessibility, environmental efficiency, safety and security.

ITD Organizational Overview



Board of Education

The seven members elected to the Los Angeles Unified Board of Education (Board) are responsible for setting District policies, including those that guide the actions of ITD. The Board also provides approval during various stages of the projects executed by ITD.

Superintendent of Schools

The Superintendent of Schools, selected by the Board, is responsible for the District’s day-to-day operations and execution of Board policy. As part of the Superintendent’s Cabinet, the Chief Information Officer facilitates development and delivery of technological services and programs to support instruction and increased business operational efficiencies.

Deputy Superintendent, Business Services and Operations

The Deputy Superintendent, Business Services and Operations reports to the Superintendent of Schools and provides administrative direction to executives responsible for business, financial, human resources and information technology and provides advisement to Facilities executives on related matters.

School Construction Bond Citizens’ Oversight Committee

As required under Los Angeles Unified voter-approved bond measures, the Board established a Bond Citizens’ Oversight Committee (BOC) to review and advise the Board and staff on the efficacy of bond fund expenditures and program development. Committee members represent a broad constituency and provide an independent review of bond-funded programs. The BOC reviews every project funded by local bond measures including review of the project’s budget, scope, and schedule, prior to action by the Board.

Project Governance and Advisory Committees

The District and ITD have established advisory and governance committees to prioritize and guide ITD projects. These entities also help to collect feedback on ITD projects and ensure projects are aligned to District and department goals.

District Technology Advisory Committee (DTAC)

The District Technology Advisory Committee (DTAC) was formed to proactively seek feedback about Los Angeles Unified's technology initiatives. ITD greatly values the voices and feedback from staff, labor representatives, parents/families, students, and community stakeholders when it comes to the implementation of technology in the District.

Governance Committees

- **Executive Governance Committee** – Established in November 2019, this committee makes decisions to authorize high value enterprise projects for implementation and addresses escalated risks and issues.
- **Instructional Governance Committee** – Established in November 2019, this committee identifies and prioritizes projects that support instruction and align with District priorities and provides status updates for major projects impacting multiple departments.
- **Business Governance Committee** – Established in September 2012, this committee identifies and prioritizes projects for business efficiency, technology improvements and compliance, and provides status updates for major projects impacting multiple departments.

Enterprise Project Management Office (EPMO)

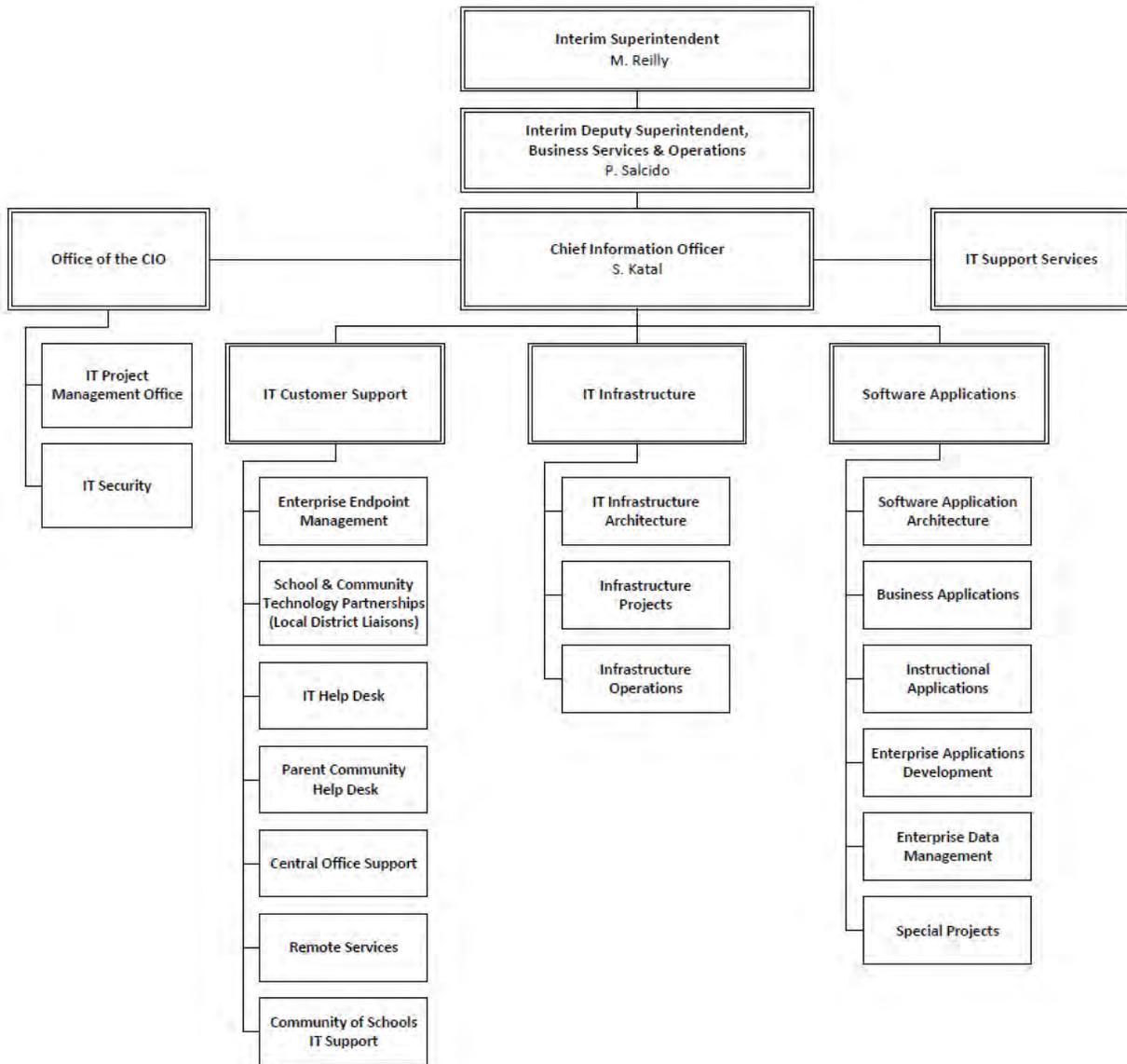
The EPMO, established in November 2019, is responsible for establishing the District's project governance to continuously improve the identification, prioritization, and management of enterprise projects, leading to enhanced visibility of enterprise projects, prioritization of and approval of high value projects, consistency in project governance, and early risk detection and escalation.

Information Technology Division Branches

The Information Technology Division is responsible for supporting the District's instructional mission and operations through deployment of robust, user-friendly, and cost-effective technology solutions. ITD's five major branches are:

- 1) **The Office of the Chief Information Officer** is comprised of the IT Project Management Office (PMO) and IT Security. The IT PMO is responsible for the development, distribution and maintenance of all project management processes, methodologies and tools. These strategies and best practice enable ITD to deliver its projects on time, within budget, and closely resembling the original project vision. IT Security is responsible for identifying IT security risks, developing policies, and implementing solutions to help protect the District's information systems and data.
- 2) **IT Customer Support** manages the IT Help Desk, Parent Community Help Desk, Community of Schools IT Support, and a host of other support groups to ensure that all Los Angeles Unified students, parents, and employees receive assistance promptly with empathy and first contact resolution at the forefront of every interaction. The branch offers remote support via telephone and chat, as well as in-person support at schools, offices, and Community of Schools Centers. The team provides field observations and assessments to all ITD teams, ensuring the continuity of telephone, internet, and radio connectivity across the district.
- 3) **IT Infrastructure** is responsible for all aspects of the District's IT infrastructure – from conception and architecture (alignment with District goals), to design, engineering, testing, selection, implementation, and maintenance. Staff operate and support the technology infrastructure necessary for instruction, learning, and daily District business.
- 4) **Software Applications** is responsible for maintaining and supporting the applications necessary for daily instruction, learning, and business. Examples of student achievement and student support applications are Student Information, Cafeteria Management, and Library Management. Instructional support applications to improve business efficiencies include the enterprise resource planning system responsible for budget, payroll, procurement tracking, and other business functions.
- 5) **IT Support Services** provides IT asset management, software compliance, and cellular services for the District and supports all areas of the Division in finance, contracting/purchasing, human resources, audit, and other administrative areas.

PROGRAMS



PROGRAM GOALS AND SCOPE

This Strategic Execution Plan serves as a catalog of ITD's Board-approved, bond funded projects. All IT projects are aligned with one of five program areas based on the type of work that will be executed. The five major program areas are:

- Classroom Technology Modernization
- Applications Modernization
- School Network Technology Infrastructure Modernization
- Safety, Communications, and Security Modernization
- Disaster Recovery and Business Continuity

The specific projects associated with each program are detailed in the ***Projects in Progress*** and ***Completed Projects*** sections at the end of this document.

Classroom Technology Modernization

Through the Classroom Technology Modernization Program, ITD actively collaborates with school and District leadership to transform how technology is leveraged in classrooms, on campus, and at home to meet Los Angeles Unified's core educational mission.

Classroom Technology possesses the catalytic power to transform and empower the way students learn and the ability to enable effective teaching and student achievement. This is evident through the District's increase in learning devices to cover every Los Angeles Unified student. Devices now serve as a cornerstone to students' educational programs, enabling access of digital curriculum; email, collaboration and other learning applications; and State-mandated formative and summative assessments.

This program encompasses bond-funded efforts focused on:

- Student learning devices, their procurement and distribution, and education of staff to maximize the benefit of these devices
- The creation and transformation of District classrooms and campuses into fertile, 21st century learning spaces that cultivate modern, personalized educational experiences

Applications Modernization

Through the Application Modernization Program, ITD deploys modern software programs that facilitate educational and school functions to meet Los Angeles Unified's core educational mission. This endeavor manifests in many ways. The District is responsible for providing educators with ready access to usable student information, which allows them to tailor their instruction to the specific learning needs of each pupil, improving teaching and learning. Likewise, a 21st century learner requires a centralized learning management platform from which the student can access personalized curriculum, assessments and grades, and communicate with teachers and peers. These interactions and the software programs that enable them are cornerstones to the District's goal of creating citizens that are college and career ready through development of 21st century computer skills. Furthermore, schools have a need to manage their food services, keep track of student attendance, and facilitate a myriad of other processes that directly and indirectly enable learning.

In delivery of education enabling applications, ITD seeks to deploy solutions that are agile, reliable, scalable, and built upon modern principles such as interoperability that extend the applications utility and useful life.

This program encompasses bond-funded efforts focused on the deployment and modernization of applications related to:

- Student Information
- Student Data and Analytics
- Learning Management
- Essential School Administration and Services, such as cafeteria management, registration and enrollment, etc.

School Network Infrastructure Modernization Program

Schools need modern, up-to-date, reliable networks to transport educational content from the Internet into the classroom, wirelessly throughout the campus, and from student to student. School networks must be robust enough to carry the entire schools' student and educator population concurrently and capable of seamlessly streaming online, interactive lessons that include rich media. Many of today's educational tools, from the students' learning management system, educational applications and email accounts to schools' student information system, cafeteria management system and student data and analytic dashboards, require a consistent, stable and robust network.

The School Network Infrastructure Modernization Program leverages previous investments and controls costs by building on, integrating, and maximizing existing systems while utilizing the most advanced and proven technologies. This approach provides wireless access and adequate capacity to meet the throughput demands created by today's instructional needs while maximizing limited bond and E-rate dollars.

This program encompasses bond-funded efforts focused on:

- School-site local area network modernizations¹
- Modernization of the District's shared central Core networking equipment

Safety, Communications and Security Modernization Program

Safe learning environments foster success. The Safety, Communications and Security Modernization Program supports the District's goal of creating safe and nurturing learning spaces by modernizing schools' communications systems, security systems, centralized network safety systems, and radio systems. Below is a brief overview of each system and its support of the learning process.

School Communication Systems also referred to as Telecommunication Services, include schools' local area networks (as of November 2019), network telephone services, intercommunication and public address systems, and clocks. Telecommunications services are essential to the District's instruction, instructional support, and safety operations. Students and staff rely upon these systems to make calls from or hear announcements in classrooms, in offices, or on other parts of the campus in both regular daily and emergency situations. Due to age, these systems are reaching / have reached the end of their useful life, and schools are now experiencing reliability and availability challenges.

School Security Systems Los Angeles Unified schools have outdated, failing and inoperable physical security and surveillance systems. These systems cost the District millions of dollars in maintenance, support costs and stolen property. This has a negative impact on students, staff, and the learning environment. Furthermore, the District must allocate resources to investigate false alarms, damage and/or theft as a result of having faulty or no alarms at all. Projects associated with this focus area replace school site security systems and enable centralized 24/7 monitoring.

¹At the end of 2019, school site local area network upgrades were incorporated into the District's telecommunication modernization efforts and thus executed under the Safety, Communications and Security Modernization Program.

Centralized Network Safety Systems The District’s community of users encompasses millions of individuals, including students, their family members, and staff. Students access District systems and the Internet for educational purposes (research, collaboration, etc.). Family members access District systems to monitor their student’s progress and communicate with teachers and administrators. District staff utilize the systems to facilitate critical processes such as attendance taking, student transportation, cafeteria management, contracts administration, and payroll services. With such a large user population accessing District systems and such critical functions reliant upon these systems, security concerns become paramount.

Without security measures in place, on-line predators threaten to steal information and inject viruses into District’s systems, resulting in resources damage or loss. Measures must also be taken to prevent District users from accessing inappropriate materials or becoming victims of cyber-bullying. Diligence in security is required to ensure that the District is compliant with local, state, and federal policies and regulations, including the Family Educational Rights and Privacy Act, the Children’s Internet Protection Act (CIPA), the Electronic Protected Health Information rules of the Health Insurance Portability and Accountability Act, and the Children’s Online Privacy Protection Act. Compliance with CIPA, specifically, is important if the District wishes to continue receiving millions of dollars in E-rate and federal funds.

Radio Systems The District’s radio systems are utilized by school staff and the LA School Police Department to facilitate both daily and emergency communications. Furthermore, the District’s Transportation department relies on the radio system to communicate with school buses. Under the Safety, Communication and Security Modernization program, ITD will replace the District’s two aging radio systems with a single, unified radio system that meets critical District communication needs and is interoperable with other public safety radio and communication networks.

This program encompasses bond-funded efforts focused on:

- Communications systems, including schools’ local area networks, telephone, Intercommunication, public address, alarms and clocks
- Security systems
- Centralized network safety systems (cyber security systems)
- Radio systems

Disaster Recovery and Business Continuity Program

The District’s mission critical information systems—including student transportation, payroll, food services, facilities, and student information—are dependent upon the operability of the District’s applications and technology infrastructure. These systems and applications are in the Data Center, which serves as the information hub for all schools and offices. Prior to the implementation of the Disaster Recovery Program, the District had a single Data Center that lacked redundant or failover capabilities. Any unexpected disaster—such as a fire or earthquake—could have caused severe damage to the infrastructure, crippling all the District’s critical systems and severely impacting teaching, learning and District operations.

The District’s Disaster Recovery and Business Continuity (DR/BC) Program addresses this risk by providing a modern performance optimized data center and a cloud disaster recovery solution to maintain critical applications and technologies to meet operational needs during or after disasters and emergencies. Disaster Recovery refers to the ability of the District to “bounce back” expediently in the event of a disaster. Business Continuity refers to the District’s ability to continue operating during a time when critical systems and applications are impacted or not available.

The Safety, Communications and Security program encompasses bond-funded efforts focused on:

- Enabling disaster recovery
- Enabling business continuity

FUNDING/COST

Overview

The Information Technology Division bond program funds projects addressing student, staff, and school stakeholder technology needs. The bond program meets many of the 21st century teaching and learning requirements. New technologies with improved processes increase operational efficiencies, maximize resources, and release funds for classroom instruction. The primary funding sources in the Strategic Execution Plan (SEP) are Measures K, R, Y, Q, and RR. The balance of funds comes from the general budget or Federal E-rate program.

Cost Management

Cost management efforts are an integral part of the culture for the team executing and managing the bond program. ITD’s systems, policies and procedures, and highly qualified staff provide proper controls, approvals, and reporting of project execution status, costs and funding sources. Using industry best practices, staff work to deliver projects within budget; control risks; identify, mitigate and manage unforeseen conditions; and manage scope changes.

Funds Management

The Information Technology Division works proactively to maximize available program funds. Leadership/executives identify and meet school needs, state mandates, and District policies through execution of projects that leverage bond funds, general funds, and Federal E-rate funds.

Source of Fund

The current bond program is valued at approximately \$837 million. The primary funding sources are local bonds totaling approximately \$817 million (97.7% of total program funding). Other sources include Federal E-rate reimbursements and General Funds.

MANAGEMENT

The Information Technology Division's management team consists of highly skilled program and project professionals with years of experience in deploying and installing technological solutions. Included on these teams are engineers with extensive experience in the District's information technology infrastructure and data systems. The programs' staff operates on three basic principles:

- Accountability
- Solution-oriented decision processes
- A commitment to continuous improvement

Program Management

The program/project management team plans and executes Bond-funded projects. Specifically, the project managers perform the following functions:

- **Design Oversight** – coordinate and maintain quality assurance of in-house and/or contract professionals' efforts to ensure compliance with industry and District specifications, objectives, and policies
- **Procurement** – when applicable, contract for professional services by working with legal and procurement staff to ensure the use of appropriate contracting vehicles and adherence to federal, state, and local laws and policies; contract types include, but are not limited to, California Multiple Award Schedule (CMAS) contracts, public works, professional services, and other competitively bid procurement contracts
- **Construction / Installation / Implementation Management** – coordinate and maintain quality assurance of installation contractors and in-house technicians; ensure that specifications, objectives, and policies are utilized; deficiencies and claims are minimized; and all required documentation is completed and delivered to the appropriate District divisions
- **Cost Management** – manage programs and budgets to ensure that program resources are optimized and that funds are properly allocated

Design Guidelines

The Los Angeles Unified Project Design Guidelines articulate the basic tenets included in the design of all information technology projects. These are:

- Specify affordable, durable, sustainable materials and technology
- Adopt a Commercial-Off-The-Shelf (COTS) solution (where feasible) vs. the implementation of a custom developed technical solution
- Utilize Application Program Interfaces (APIs) and Micro-Services to lower the transaction size and reduce data latency

Reporting

ITD provides full disclosure of its methods, data, and implementation performance for the programs of this Strategic Execution Plan with mandated oversight requirements. The following guidelines outline the Division's reporting standards:

- Establish baseline information on scope, schedule, and budget, then measure current performance against these baselinemetrics
- Report to stakeholders in relevant, easy-to-understand reports
- Provide early warning of potential variances from anticipated results so that decision makers are presented with mitigation options in a timely manner
- Post reports on a District website for ease of distribution

In addition to annual update of the Strategic Execution Plan, ITD provides a quarterly status report to the BOC at their public meetings, identifying progress made towards achieving program's goals and status.
