Minutes

I. CALL TO ORDER

Paul Robak, the PAC Chairperson called the meeting to order at 10:00 am and welcomed those in attendance. Then recessed for 10 minutes, reconvening at 10:10 am.

II. PLEDGE OF ALLEGIANCE

The flag salute was led by Maria Barboza, a PAC alternate from Local District Central.

III. ROLL CALL

Members were seated and roll call was called by Juan Godinez, the PAC Secretary at 10:14 am. Quorum was not established with 27 members present at the time (28 needed).

At 10:20 am, quorum was established with 31 members present. One member left at 10:24 am. At 10:30 the alternates were seated bringing the membership total to 34. At 11:00 am., by the time members and alternates are allowed to be seated, there were 36 voting members present.

IV. PUBLIC COMMENT

Members of the public were given the opportunity to address the committee. There was no public comment.

V. PACKET REVIEW

Contents of the packet were reviewed by Estela Lopez-Spears, the PAC Public Relations Officer.

VI. UNFINISHED BUSINESS

Form a Standing Legislation Subcommittee.

A motion was made by Mayra Zamora, PAC member, to form a Standing Legislation Subcommittee; seconded by Daisy Ortiz, PAC member. After discussion on the motion a vote took place.

Voting results were: 17 in favor, 8 against and 8 abstentions. The motion passed.

LCAP comments development continued.

The membership broke into 6 working groups to continue the development of LCAP comments on the LAUSD six LCAP goals. After the hard work:

Bryan Davis, PAC member, moved to approve the LCAP comments to be forwarded to the Superintendent for response; seconded by Roberto Fonseca, PAC member.

Voting results were: 24 in favor, 0 against, and 0 abstentions.

Voting results were: 11 in favor, 0 against, and 0 abstentions.
