IV. Chairperson's Report

During the last few weeks I have had very enriching experiences, especially participating in the conference of all titles, with other central committees. It was inspiring to meet engaged educators and administrators in California, where the state's priorities align with those of parents and their communities. An important reflection was that we don't always need to reinvent the wheel; the resources and programs already exist, and our challenge as CAC members is to learn how to use them effectively to benefit our students. A valuable piece of advice I received from the California Department of Education was that the Education Code represents the minimum required, not the maximum possible. This gives us room to drive meaningful improvements from our districts. In addition, they informed me about CDE resources for free translations, which is crucial to supporting families facing language barriers. I will investigate it further and encourage you to do the same. The most inspiring aspect of the conference was the presentation by deaf students from the school in Riverside. We learned sign language to participate with them and it was a very emotional experience. It made me reflect on the importance of inclusion, direct contact and respect when communicating, as well as the commitment to act after witnessing a need. This reaffirms that our work at the CAC must not only observe, but also act to support all students and the staff who support them. Since we are in March, it is time to think about our priorities and how we can to continue moving forward with purpose.

V. <u>Division of Special Education (DSE) update.</u>

José Soto, Executive Director of Special Education:

José Soto shared several important updates with CAC members:

CAC Elections: They will be held in person. The information leaflets have already been distributed in the communities. All information is available on the updated website: sped.lacoe.org/cacelections.

Legislative Exchange Day: Will take place on Wednesday, April 30. An interest form was shared with CAC members to participate in the delegation. Only four members will be selected to attend. If there are more than four interested parties, a draw will be held, prioritizing those who have not attended in the last three years.

Website Update: Lilia, who is leading this effort, will introduce the new design and functionalities. The site is now live and contains information relevant to the CAC.

The Division of Special Education's new website:

The Division of Special Education's new website was introduced, being one of the first launched within the district. This new space was developed taking into account the comments received in surveys, especially from parents and members of the CAC, who are thanked for their valuable feedback.

- **Easy navigation:** The site is designed to make the most important resources accessible with a single click.
- Machine translation: Available so that the content can be read in different languages.
- **Custom web addresses:** For example, the parent section will have a URL with the word "parents" at the end for easy access.
- **Key Resources:** Includes direct access to handouts, workshop recordings, educational materials, and more.
- **Updated Visual Content:** Representative photos of students from different schools in the district are being included.

The entire community was invited to visit the website and continue to participate as it will continue to be constantly improving. The entire LAUSD Office of Government Relations works to ensure that the school district and our students benefit from important legislation and funding. In fact, they have already adopted the 2025 defence agenda, which is guided by key principles and priorities.

A link is available for you to check it out. This work includes advocating for local laws and advocating for federal funds, such as the *Stay Three program* and other essential resources.

If you have the opportunity, we encourage you to review the advocacy agenda to learn LAUSD's position on securing additional funding and proposed changes that seek to strengthen both our students and the education system as a whole.

In addition, we will soon share information related to our data metrics.

VIII. Presentation: End disproportionality.

<u>Tiffany Mack, Coordinator, DSE Delshaun Lanier, Coordinator, DSE Sukari Garlington, Administrative Coordinator, DSE</u>

Objective of the presentation:

The presentation will provide an overview of Comprehensive and Coordinated Early Intervention Services (CCEIS), review the action plans that guide their implementation, and explain how these services address differences among students with disabilities through specific strategies, supports, and interventions.

IDEA requires states to oversee local educational agencies to address

disproportionate representation of students from diverse racial and ethnic groups in special education. Disproportionality refers to an over- or under-representation of these students in special education or gifted programs.

The California Department of Education (CDE) identifies significant disproportionality in local educational agencies (LEAs) when there is an overrepresentation of certain racial or ethnic groups in:

- Specific categories of disability,
- Disabilities in general,
- Specific educational environments,
- Disciplinary measures.

Disproportionality in the Los Angeles Unified School District (LAUSD)

LAUSD has been identified as disproportionate in two areas:

- Disciplinary action targeting African American students.
- Eligibility assignment to African American students in the Emotional Disability (ED) category.

CCEIS campuses receive professional development, materials, additional support, and the implementation of the Accelerated Learning Academy (ALA) in select schools.
