Wednesday, October 30, 2019 – 10:00 am – 1:00 pm

Call to Order/Welcome

Welcome and opening remarks by Antonio Plascencia, Jr., Interim Administrator, at 10:06 a.m. He thanked the parents for coming and introduced the PCS staff. He introduced Leah Brackins, Sr. Parent Community Facilitator.
