- There is a Special Local School Funding Election on June 4, 2019. The Los Angeles Unified School District Board of Education voted unanimously to place **Measure EE**, a 16 cent per square foot parcel tax, on the ballot in a special local school funding election.
- On May 28, 2019, the Chairpersons from CAC, DELAC and PAC made a presentation to the Committee of the Whole. Mr. Robak represented the PAC.
