- The CALPADS submission process was reviewed. Each LEA will use their electronic IEP vendor-developed application program interface (API) to electronically transfer data to CALPADS. Records with errors will be returned to the LEAs. LEAs are responsible for making the corrections to the reports. For the 2019 fall CALPADS submission, the following dates apply:
 - September 10, 2019 – SWD Functionality Release
 - October 2, 2019 – Census Day
 - December 6, 2019 – LEA Approval (CDE not enforcing this date, describing it as best practice)
 - December 20, 2019 – SELPA Approval
 - January 24, 2020 – Fall I Amendment Deadline
