**District Updates**

- There is a Special Local School Funding Election on June 4, 2019. The Los Angeles School District Board of Education voted unanimously to place **Measure EE**, a 16 cent per square foot parcel tax, on the ballot in a special local school funding election. Measure EE will provide additional locally controlled school funding.
- “The Work Ahead” is the new name of LAUSD Reimagine Work. We will be hearing more regarding the work ahead in the next few months. As a reminder, the focus of all of central offices is to focus on supporting schools and Local Districts. We are here to support the parents at the schools and local districts.
