**MINUTES**

**I. Call to Order**

Diana Guillén, Chairperson called the meeting to order at 9:40 a.m.

**III. Roll Call/Establish quorum**

Heidy Galicia, secretary, conducted roll, quorum was established with 27 members at 10:03 a.m.

**IV. Approval of Minutes dor March 24, 2022**

Heidy Galicia, secretary, proceeded to read the minutes for March 24 2022 aloud. Ms. Guillen asked the membership if there were any corrections. Ms. Guillen entertained a motion to accept the minutes with corrections. Rocio Elorza made the motion to accept the minutes without corrections, motion seconded by Juanita Garcia la segunda. 24 votes in favor, 0 against, 0 abstentions, motion passed.

**V. Chairperson's Report**

Ms. Guillen began her report making emphasis on a book called "The Art of War" by Sun Tzu and highlighted the following two phrases:

1. The principle objective of war is peace
2. Give a voice to the voiceless

She spoke about the importance of working together as a team and reviewed the budgets:

She thanked the Principal who shared the information with her. He gave it as an example of when a director wants to work with parents. Mrs. Guillen presented a proposal, that all funds received from the state and federal government in each school are consulted with the parents of the ELAC's and that it be a requirement that the advisement given by the parents be reflected in the input of the budget and these are fully presented to the school community.

**Sra. Guillen asked if there was a member that wanted to present a motion.** Delmy Nuñez made the motion, seconded by Antonieta Garcia. The motion passed with 27 votes in favor, 0 against, and 1 abstention.

**VI. Presentation: PCS Budget and Initiatives 2021-2022; 2022-2023 school years**

Antonio Plascencia, Director thanked the members and continued to present on Goal 4: Parent, Student, and Community Engagement. He informed the members of the funding the Office of Parent and Community Services receives and highlighted the impact of parent participation. He talked about the Superintendent's 100 Day Plan and mentioned that one of the priorities are the Parent Academy 8 session series that will focus on equity for English learners, African American students, Exceptional Needs, and Early Childhood Education.

PCS works hand in hand with the PACE teams in the Local Districts. Mr. Plascencia continued to share that we are working on a format/training that provides guides regarding services and training resources and that 80% of the budget is used in personnel. PCS has 15 staff members. This budget looks different than in the past given the pandemic. Next year we will be able to lend our devices to committee members. These funds are smaller due to the pandemic. Computers were purchased for the parents. We received one-time funds that were given to the schools. Funding will be increased as we may meet in person or hybrid. There was \$123,319 left without allocation to cover any other needs.

Members were asked to fill out the survey to let us know how we can continue assisting them in their personal development. How can we improve services? What topics would you like to receive next year?

**VII. Comment Development LCAP Goals 1-6:**

Dr. Chau provided provided a brief overview and asked the members to voice their opinions and ideas and provide feedback. If you cannot access Thought Exchange, please write in the chat. The Superintendent is interested in hearing the members' voice. They explained the Thought Exchange process.

- A brief summary for each goal was provided: 100% Graduation, Proficiency for All, Excellent Attendance, School Safety & Climate, and Basic Services. Members were given the opportunity to provide comments and feedback out loud in the chat.

Motion: Mr. Rios made a motion to extend the meeting 30 minutes, Ms. Irma Lopez seconded the motion. The motion passed with 26 members in favor of the motion.
