UPDATES AND HIGHLIGHTS

Extended School Year (ESY) 2025 Registration Now Open! Registration for ESY 2025 is now underway! Families can confirm their child's ESY registration in the following ways:

- Parent Portal Visit the LAUSD Parent Portal to view and confirm your child's registration.
- 2. Parent Confirmation Letter A confirmation letter was mailed to families. If the letter is missing or was not received, a new one can be requested from the child's school of attendance and returned to the school to complete registration.

PROFESSIONAL DEVELOPMENT AND TRAINING FOR DISTRICT STAFF

Special Education Micro-credential for Teachers

The Special Education TK–12 Instruction team developed the Special Education Micro-Credential to allow teachers to expand their learning and deepen their understanding of special education practices. This program has broadened teachers' knowledge, increased awareness, and strengthened competencies in serving students with disabilities. The culmination of the first cohort of the Special Education Micro-Credential Program will take place in June 2025.

Behavior Support Training Completion Highlights

This year, schools across the district have made significant progress in strengthening behavior support systems through targeted training initiatives. Hundreds of school teams have completed professional development designed to enhance their ability to create safe, supportive learning environments for all students.

- BE-PaRT Recertification Training
- Positive Behavior Support Symposium for Special Education Paraprofessionals
