- V. **Roll Call/Establish Quorum:** Mrs. Lluvia Sainz, secretary, conducted roll call at 10:31 a.m. and established quorum with 28 members including the alternates.
- VI. **Chairperson's Report:** The chairperson did not send a written report to the members. However, she presented it orally. She mentioned that the executive board has been working on the LCAP comments. It was a complicated process; they were at SFACE on Friday from 9:30 a.m. to 5:00 p.m. and did not finish; we returned on Monday from 9:30 a.m. to 1:00 p.m. The executive board worked hard to get their voices and comments heard. We worked to make comments more consistent and added additional information to them. So that the district can respond to our comments. We noticed that several comments were the same, so we wanted to present them all in one. The chairperson gave the PAC members the opportunity to ask questions.

VII. Action Item- Minutes: Minutes for the months of June 7, 2024, February 20, 2025 and May 1, 2025. A motion was made to approve the minutes with all the necessary additions, deletions and/or corrections. Member Christian Ponciano made the first motion and member Dr. Amber Marie Jones seconded the motion.

Better state compliance will be recommended as the audit applies. It was also mentioned that there will be more responsibility and results from the financial audit. The PAC chairperson gave members the opportunity to read the comments and make some corrections. A motion was presented by Dr. Amber Marie Jones.

And there will also be mental health and communication with families and parents. Also, that they should perform well in school. The membership was given the opportunity to ask questions.
