November 16, 2016

CALL TO ORDER/WELCOME

The welcome was given by Alvaro Alvarenga, Administrator, PCSS at 10:19 a.m.

PLEDGE OF ALLEGIANCE

The flag salute was led by Jacquelyn Smith Conkleton, CAC member.

PCSS Update

Mr. Alvarenga emphasized that this was the only committee whereby each member has to be approved by the Board of Education. He also introduced Lisa Kendrick, SELPA Director and Pilar Sanchez, Interim Parent Engagement Specialist, from the Division of Special Education. They briefly shared their role in supporting the CAC by: attending CAC meetings, providing monthly SELPA and Division updates, as well as organizing speakers to advise on the Local Plan.

Mrs. Rowena Lagrosa welcomed everyone. She commended the CAC members for their hard work and dedication to all students. Mrs. Lagrosa wished them a great year.

Alvaro Alvarenga introduced the PCSS support staff Leah Brackins, Angie Cardenas, Lisa Porter, Darius Adle, Jose Escalante and Tracey Waterman. Everyone will work towards a smooth election process today.

PUBLIC COMMENTS

The public was allowed a limited time of two (2) minute per speaker to address the membership (Pursuant to Board Rules 131-137).

Public Comments were facilitated by Mr. Alvarenga.

There was only one public comment given at this meeting.

ROLL CALL/QUORUM

Roll was called by Leah Brackins

Members were seated and roll call was conducted by Leah Brackins.

Quorum was established at this point. There were 19 members present.

ORIENTATION

Officers' Roles and Responsibilities:

Mr. Alvarenga indicated that the CAC also reaches out to private schools. Five officers will be elected today.

Review of the Election Process and Guidelines:

Election guidelines were read and reviewed by Leah Brackins as distributed to all members. She indicated that if no one has the majority of votes in the first round, then there is a second round among the top two votegetters.

Leah indicated that only parents of Special Ed students can run as Chairpersons or Vice Chairperson and that the other offices were open to the entire membership. A blue sheet with 14 election guidelines was distributed. A brochure on Orientation and election of CAC members was also distributed. The CAC shall consist of 32 members and 2 parent alternates appointed by the Board of Education. Of the 32 members a minimum of 17 and maximum of 22 parents of pupils enrolled in schools participating in the local plan, and such parents shall be parents of individuals with exceptional needs or disabilities enrolled in public or private schools within LAUSD.

We are going to select 8 plus 2 alternates. We need 2 parents of "General Ed" students.

The duties of each CAC officer were explained. There is a new position this year: Public Relations Officer, besides the regular positions of Chairperson, Vice Chair, Secretary and Parliamentarian.

The CAC operates under the Brown Act.

Reimbursement for transportation is available only to CAC members and alternates who bring their cars or arrive by public transportation within the first 30 minutes of posted meetings and stay at least 2 hours.

There is reimbursement for child care from birth to 5 years of age. One question was raised whether there can be exceptions with the CAC as some older children need special care.
