## PARENT ADVISORY COMMITTEE OFFICIAL ELECTION MINUTES

October 26, 2017

#### CALL TO ORDER/WELCOME

Welcome and opening remarks by Dr. Rosalinda Lugo, Administrator at 10:00 a.m.

Dr. Lugo went over her learning experience at the Office of Parent and Community Services after being administrator for Local District West and Principal in Westside schools. She said that the PCS staff were all learners as well. She introduced all the administrators and then all the additional staff at PCS. She pointed to Jose Escalante who does ITD support and said that she wanted children to connect to PASSport so an adult monitors them.

Dr. Lugo added that today was sports/college day at PCS and pointed to all the college banners. She said, "Remember our motto is Kids First". Why should parents be actively involved in our schools? Kids! In January 2018 or maybe as early as December, PAC recommendations will be presented to the Board of Education.

Dr. Lugo then introduced Ms. Christine Woods from the General Counsel's office, Antonio Plasencia from the Superintendent's office and Ankur Patel from Board Member Scott Schmerelson's office.

She briefly went over the rules of the election including no cell phone use and other matters like no campaigning. Lisa Porter will be the electioneer, Gloria Acosta will distribute ballots, Leah Brackins will collect ballots, and Jose Escalante will record and tally the ballots. Ms. Panossian and Dr. Mahmud will monitor the proceedings on both sides of the room. Alvaro Alvarenga will be the Election Judge.

The flag salute was led by <u>Jacquelyn Smith Conkleton</u>.

#### **PUBLIC COMMENTS**

The public was allowed a limited time of two (2) minutes per speaker to address the membership (Pursuant to Board Rules 131-137).

Public Comments were facilitated by Alvaro Alvarenga. Five (5) people gave comments for 2 minutes each.

#### **GROUNDING ACTIVITY**

Mr. Alvarenga, Administrative Coordinator, Office of Parent and Community Services led a grounding activity.

#### ORIENTATION FOR PAC MEMBERS AND ALTERNATES

He reviewed the purpose of the Parent Advisory Committee and the important role it plays, emphasizing the expectations for PAC members, the duties, responsibilities and expectation for PAC Officers.

Mr. Alvarenga went over the Local Control and Accountability Plan (LCAP). He told the parents to remember that they represent a million parents as, even though the District has now fewer students, there are still 500,000+

students, and Superintendent King responds to your recommendations. He then went over the composition of the LCAP and the PAC:

Parents/guardian of a student that participates in the Free and Reduced Price Meal Program,

Parents/guardian of a student identified as an English Learner

Parents/guardian of a student enrolled at the school (Parent At Large)

Parents/guardian or agency serving Foster Youth students

Board District representatives, each board member selects one parent, thus there are 7 such members.

#### **ROLL CALL/QUORUM**

Members were seated and roll call was conducted by Angie Cardenas, Senior Parent Facilitator.

Quorum was established at <u>28</u>. There were <u>46</u> voting members present. Quorum was reached.

Election guidelines were distributed to all members, read and reviewed by <u>Leah Brackins</u>, <u>Senior Parent</u> Facilitator.
