QUESTION:

Please clarify the response requirements for Pgs 6-7, for Financial Conditions, Safety Records, and Labor Compliance. It appears that Financial Condition only requires a Letter of Bondability, but what submissions or documents are required for the Safety Record and Labor Compliance?

RESPONSE:

Financial Condition: The RFQ requires proposers to submit one notarized statement of bondability from an admitted surety insurer (approved by the CA Dept. of Insurance) with at least an A-VII A.M. Best Rating which must state the proposer's current available single and aggregate bonding capacity, addressed to the District, and accompanied by a Power of Attorney from the surety company (mandatory).

Safety Record: The RFQ does not require supplemental attachments. However, Proposers are to provide the required safety record information as indicated in the RFQ and include in its RFQ/SOQ submittal.
