Discussed the Feb. 28, 2022, announcement from CA Health & Human Services (HHS) that after March 11, 2022, masks will no longer be required, but are still recommended, in CA public schools and childcare centers. Local jurisdictions may implement additional requirements beyond the state guidance based on local conditions, including community vaccine rates or vaccination rates in schools.
- 2. Discussed with Board members that the bylaws and board policy do not address board member attendance at Board meetings or expectations for continuing board membership. The Board members present suggested that "a gentle nudge" be given to any Board member who misses three meetings in a year to ensure that they are still committed to remaining on the Board. And, after 5 or 6 meeting absences, a more direct approach may be supported.
- 3. Followed up on Board member completion of the annual Form 700, Statement of Economic Interests. All forms for the school's official record must be wet-ink originals.
