

NOTICE TO THE RESIDENTS OF THE BRISTOL TOWNSHIP SCHOOL DISTRICT

NOTICE is hereby given that the Board of School Directors of the Bristol Township School District, Bucks County, Commonwealth of Pennsylvania, intends to adopt, at its regularly scheduled meeting on Monday, November 18, 2024, at 7:30 P.M. at School District's Administrative Building, located at 5 Blue Lake Road, Levittown, Pennsylvania the following Resolution:

A RESOLUTION OF THE BOARD OF SCHOOL DIRECTORS MAKING CERTAIN AMENDMENTS TO THE VOLUNTEER SERVICE TAX CREDIT PROGRAM UNDER SCHOOL BOARD RESOLUTION NO. 06282023.

Pursuant to the Act of November 21, 2016, P.L. 1509, No. 172 (otherwise known as "Act 172"), and any amendments thereto, the School District is providing this Notice of its intent to enact a resolution amending Resolution No. 06282023, which established a volunteer firefighter and emergency medical services tax credit program for qualifying volunteer firefighters and emergency medical services personnel who are volunteers of the volunteer fire companies and nonprofit emergency medical service agencies that provide service to School District residents. A brief summary of the proposed Resolution is as follows:

First, the Resolution amends Section 2 – "Volunteer Service Tax Credit Program," Subsection C – "Program Criteria for Fire Companies," Paragraph iii, of Resolution No. 06282023 to add a new subparagraph d – "Category Three" to provide points for years of aggregate service as an Active Volunteer with a Fire Company. Second, the Resolution amends Section 2 – "Volunteer Service Tax Credit Program," Subsection D – "Program Criteria for Emergency Medical Service Agencies (EMS)," Paragraph iii, of Resolution No. 06282023 to add a new subparagraph d – "Category Three," to provide points for years of aggregate service as an Active Volunteer with an Emergency Medical Service Agency. Third, the Resolution amends Section 10 of Resolution No. 06282023, which relates to the ratification of prior actions, for clarity. Fourth, the Resolution contains an Exhibit A, which restates the operative parts of the Volunteer Service Tax Credit Program as established by Resolution No. 06282023, as amended by this Resolution. In the event a discrepancy exists between the text of Resolution No. 06282023, as amended by the Resolution, and the text of Exhibit A, the text of Resolution No. 06282023 as amended by the Resolution shall control. Fifth, the Resolution contains a severability clause. Sixth, the Resolution provides for the ratification of prior actions taken by certain officials and personnel in connection with the Resolution.
